## **VALID FORMS OF PHOTO IDENTIFICATION**

- ★ A VALID ALABAMA DRIVER'S LICENSE OR NONDRIVER IDENTIFICATION CARD WHICH WAS PROPERLY ISSUED BY THE APPROPRIATE STATE OR COUNTY DEPARTMENT OR AGENCY;
- ★ A VALID ALABAMA PHOTO VOTER IDENTIFICATION CARD:
- ★ A VALID IDENTIFICATION CARD ISSUED BY A BRANCH, DEPARTMENT, AGENCY, OR ENTITY OF THE STATE OF ALABAMA, ANY OTHER STATE, OR THE UNITED STATES AUTHORIZED BY LAW TO ISSUE PERSONAL IDENTIFICATION, PROVIDED THAT SUCH IDENTIFICATION CARD CONTAINS A PHOTOGRAPH OF THE ELECTOR;
- ★ A VALID U.S. PASSPORT;
- ★ A VALID EMPLOYEE IDENTIFICATION CARD CONTAINING THE PHOTOGRAPH OF THE ELECTOR AND ISSUED BY ANY BRANCH, DEPARTMENT, AGENCY, OR ENTITY OF THE U.S. GOVERNMENT, THE STATE OF ALABAMA, OR ANY COUNTY, MUNICIPALITY, BOARD, AUTHORITY, OR OTHER ENTITY OF THIS STATE;
- ★ A VALID STUDENT OR EMPLOYEE IDENTIFICATION CARD ISSUED BY A PUBLIC OR PRIVATE COLLEGE, UNIVERSITY, OR POSTGRADUATE TECHNICAL OR PROFESSIONAL SCHOOL LOCATED WITHIN THE STATE OF ALABAMA, PROVIDED THAT SUCH IDENTIFICATION CARD CONTAINS A PHOTOGRAPH OF THE ELECTOR;
- ★ A VALID U.S. MILITARY IDENTIFICATION CARD, PROVIDED THAT SUCH IDENTIFICATION CARD CONTAINS A PHOTOGRAPH OF THE ELECTOR; OR
- ★ A VALID TRIBAL IDENTIFICATION CARD CONTAINING A PHOTOGRAPH OF THE ELECTOR.

If you do not have any of the above listed forms of identification, you will be permitted to vote by either of the following two ways:

- 1. A Provisional Ballot, as provided by law.
- 2. The Voter is positively identified by two election officials as a voter on the poll list and the election officials sign sworn affidavits so stating.
