### HANCOCK COUNTY ONLY

RULES:

1. Classes will be determined by weight on the day of the show and will include a novice weight class (Novice will not show for champion.).
2. Open to youth 8-19 that are enrolled in a 4-H or FFA Market Lamb Project.
3. All exhibitors should be prepared to present health papers if requested.
4. Lambs should be shorn for show.
5. Showmanship classes will begin show (see classes listed below).
6. Hancock County youth only.
7. The show committee shall rule on any questions arising and not covered by other rules.
8. Lambs must be owned and cared for by youth exhibiting animal.
9. Livestock Record Book must be completed and turned in.

### HANCOCK COUNTY ONLY

1. All goats must meet Kentucky Health requirements for exhibition.
  2. Exhibitors may enter market weathers or market does. All weathers must be clean castrated.
  3. All goats must have been born after August 15, 2017.
  4. All goats will be shown by weights. All goats must weigh a minimum of 40 lbs. On show day.
  5. Exhibitors 8 years old and younger as of January 1, 2018 are eligible to compete in the Novice weight class.
  6. Exhibitors are limited to 4 market goats; novice limited to one.

  - Class 2 - Grand Champion ..... Rosette
  - Class 3 - Reserve ..... Rosette
  - Class 4 - Showmanship - Novice (8 yrs and under as of 1/1/16) ..... Rosette
