Evens was born on August 23, 1983, is 6'0 and weighs 220 lbs. He has black hair and brown eyes. Last known address is N.



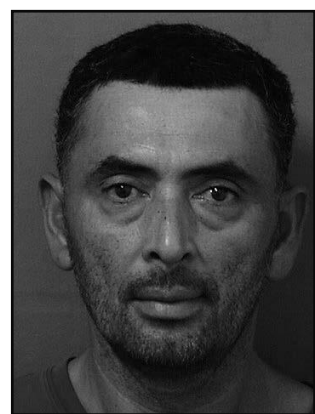
