# Longtime *Herald* publishers retire, paper welcomes new owners

Longtime publishers and owners of the Holmes County Herald newspaper, Bruce and Libby Hill, officially relinquished their roles on Thursday, March 8 to Shoccoe Media, LLC as new owner of Holmes County's longest operating news publication.

The Holmes County Herald printed its first issue on January 22, 1959 under the ownership of the Holmes County Publishing Company with Chester Marshall serving as editor. In October 1960, Jack Shearer became the editor. He served until November 1962 when Paul Tardy became the editor. On July 15, 1965, Tardy was the owner, changing the ownership to Holmes County Herald. On March 18, 1970, the ownership of the Herald changed to East Holmes Publishing Enterprises, Inc.
