AmeriPride Services Inc, Durant Plant, located at 105 Landrum Street in Durant, MS, (662) 653-0056, has applied to the Mississippi Department of Environmental Quality for the following permitting action: Issuance of Synthetic Minor Permit to Operate Air Emissions Equipment, Ref. No. 1140-00061. The applicant's operations fall within SIC Code 7218. A Statement of Basis has been prepared that contains a discussion of the decision-making that went into the development of the permit and provides the permitting authority, the public, and other government bodies a record of the technical issues surrounding issuance of the permit. The Statement of Basis also addresses any changes to emissions and/or discharges resulting from any modification of the facility. AmeriPride Services operates an industrial laundry facility that launders soiled textiles including linens, uniforms, towels, mats, dust mops, and other garments. The facility achieves this by operating natural gas-fired equipment including a boiler, a heater, a steam tunnel, and dryers. When the facility was acquired by AmeriPride, potential emissions were evaluated, and it was determined to require air permitting for volatile organic compounds (VOC) and hazardous air pollutants (HAP). As such, AmeriPride has proposed to control these emissions by limiting the amount of laundered shop towels. This will ensure VOC and HAP emissions do not surpass the Title V threshold of 100 tons per year of VOC, 25 tons per year of total HAP, and 10 tons per year of individual HAP.
