MINUTES OF THE BOARD OF EDUCATION

Independent School District No. 820

Sebeka, MN 56477

Regular meeting Monday, September 10, 2018

The regular meeting was called to order at 6:00 p.m. The following members were in attendance: Nate Erickson, Charles Funk, Rod Huttunen, Russell Johnson, JoAnn Olson, and Bryan Pederson. Absent Eric Nelson. Also present were Superintendent Dave Fjeldheim; Principal Amie Westberg; Business Manager Holly Paulson; Activities Director Jon Lillquist; staff members Missy Wattenhofer and Dave Kerkvliet; and *Review Messenger* Reporter Roy Rudderforth.

Olson moved, Erickson seconded to approve the agenda with the addition of 9.6 Approve AWF Professional Wrestling event. Motion carried unanimously.

The School Board took time to remember retired teacher Linda Smith who passed away and to send condolences to her family.

Mr. Fjeldheim gave an update on the construction noting that they are starting to put up the steel beams, pipes have been framed for the electric; and discussed an early out for students and staff on Friday, September 28th to allow for the electricity to be shut off so the transformer can be moved. Jim Theurer was also present to report updates to the school board at the end of the meeting.

Business Manager Holly Paulson reported on the Title I applications were completed and submitted to MDE; beginning of year paperwork was distributed to staff; Special Ed wages submitted to Freshwater for the SEDRA system; and audit focused on GASB 75 and Student Activities.

Activities Director Jon Lillquist reported on Fall sports participation numbers: Volleyball: A,B, and C - 29 girls; Junior High (6th-8th grade) 21 girls; Cross Country: 14 girls in grades 7th-12th (4 from Sebeka-10 Menahga) and 9 boys in grades 7th-12th (1 from Sebeka-8 Menahga); Football: 38 in grades 9th-12th (18 from Sebeka - 20 Menahga), Jr. High Football has 38 participants (13 from Sebeka-25 Menahga) and requested approval to host a professional wrestling event (AWF) on October 13th noting that sports that provide workers would split the profits.

Principal Mrs. Westberg reported on (1) first day of school had teachers doing activities with students instead of going over rules; (2) Nancy Huhta, Cathy Baumgart, Tera Oakland, Lori Anderson and Mrs. Westberg attended a workshop on "Strategies for Cafeteria and Recess"; and (3) Mrs. Kern and Mr. Roberts went to elementary classrooms to talk about the ALICE protocol.

Superintendent Mr. Fjeldheim reported on (1) beginning of year starting out well; (2) new teachers are adjusting well and with the mentor system in place through Q-Comp there will be additional support in place for hopefully a successful transition; (3) will be attending a School Finance Levy workshop on Thursday, September 20th and (4) reviewed dates for MSBA training for Phases III & IV; reviewed ACT results for 2018, MCA district testing comparisons for the twelve area schools noting that Sebeka proficiency ratings ranks us fourth among area schools in Math, seventh in Reading and third in Science, high school class schedule with enrollment numbers in each class, Perkins 2018-2019 funding to the district, and the PMA Bond Portfolio Management report.

Under the Discussion Items, Mr. Fjeldheim reviewed beginning of the year details, staffing, enrollments in secondary classes, other programming that will be implemented this year, etc.; reviewed his goals from the 2018-2019 school year; and dates and locations for the MSBA Fall Advocacy meeting and MREA Fall area meetings and the MREA Fall Conference November 11th -13th and the MSBA Leadership Conference January 17th and 18th.

Funk moved, Pederson seconded to approve the following consent agenda items:

- The August 13th regular meeting minutes;
- The Treasurer and Investment report for September;
- Monthly bills at \$743,234.34 this also includes Construction fund bills;
- Accept gifts and donations
- Assignment of Jenny Lillquist as Jr. High Volleyball Coach;
- Assignment of Missy Wattenhofer as Concessions Stand Supervisor;
- Assignments of Krissy Tellers and Amy Lillquist as paraprofessionals;
- Resignation of Anna Skaro as ECPE Assistant
- September Enrollment at 496 K-12.

Motion carried unanimously.

A teleconference was done with Luke Evenson, auditor from Eide Bailly, to review information on the 2017-2018 audit. He noted that overall the audit was very good with a surplus of over \$50,000 and minimal findings.

Erickson moved, Johnson seconded to approve the first reading of the 2017-2018 audit report indicating a surplus of nearly \$60,000.00 from the previous year. Motion carried unanimously.

Funk moved, Olson seconded to approve the proposed 2018-Payable-2019 Tax levy by maximizing the levy with final approval done at the December 10th Truth in Taxation meeting. Motion carried unanimously.

Pederson moved, Johnson seconded to approve the first reading of the 2018-2019 Teacher Handbook as presented. Motion carried unanimously.

The Board reviewed the three bids that came in for the school forest timber bid; Edin Logging out of Staples for \$19,505; Potlatch Land and Lumber out of Bemidji for \$22,210; and Dick Walsh Forest Products out of Park Rapids for \$25,514.

Funk moved, Pederson seconded to approve the timber sale bid to Dick Walsh Forest Products for \$25,514.00. Motion carried unanimously.

Mr. Fjeldheim reviewed quotes received regarding fuel options for the 2018-2019 school year in regards to either purchasing our own fuel tank or continue to stay with our local suppliers.

Funk moved, Pederson seconded to approve purchasing our fuel for the buses from our local suppliers for the 2018-2019 school year. The following voted in favor: Erickson, Funk, Huttunen, Olson, Pederson; the following against: Johnson. Motion carried.

Erickson moved, Olson seconded to approve hosting an AWF professional wrestling event on October 13th at 7:00 p.m. Motion carried unanimously.

Funk moved, Olson seconded to adjourn the regular meeting at 8:00 p.m. Motion carried unanimously.
