## 2017 Georgia Quality Cotton Award Winners

The 2017 Georgia Quality Cotton Awards were presented at the Georgia Cotton Commission's 11th Annual Meeting and UGA Cotton Production Workshop on January 31, 2018 in Tifton, GA. The awards are co-sponsored by the Georgia Cotton Commission and Bayer CropScience, and administered by the University of Georgia Cotton Team. The purpose of the awards are to recognize producers and ginners of high-quality cotton fiber and to identify their general man-

agement practices for the benefit of other growers. The producers and their gins received a plaque and the winning producers received a \$500 cash award. The UGA County Extension Agent for each winner was also recognized as they work closely with the farmers during the growing season. The awards are given in each of these three cotton acreage categories: 1) less than 500 acres, 2) 500 to 1,000 acres, and 3) greater than 1,000 acres within the four regions of the state. Winners in these categories are determined by the

loan value and premiums of their cotton. The winners' excellent achievements are due largely to their management practices and expertise. The sponsors of this program congratulate all of the following winners:

Region 1: Less than 500 acres – Robert Rawlins of Turner County, Sconyers Gin and Warehouse with agent Will Gay. 500 to 1,000 acres – Lee Mays of Wilcox County, Sconyers Gin and Warehouse, with agent Andrew Sawyer. Greater than 1,000 acres – Donnie Keene of Wilcox County, Sconyers Gin

and Warehouse, will agent Andrew Sawyer.

Region 2: Less than 500 acres – Van Hiebert of Jefferson County, Midville Warehouse, with agent Pam Sapp. 500 to 1,000 acres – Buckhead Creek Farms of Jenkins County, Midville Warehouse, with agent Jason Mallard. Greater than 1,000 acres – Sandeford Farms of Burke County, Midville Warehouse, with agent Peyton Sapp.

Region 3: Less than 500 acres – Charles Sumner of Tift County, Omega Gin Company, with agent Scott Carlson. 500 to 1,000 acres –

G.A. Farms of Tifton County, Omega Gin Company, with agent Scott Carlson. Greater than 1,000 acres – Ken Hall Farms of Worth County, Omega Gin Company, with agent Blake Crabtree.

The final award given was the overall Best Cotton Award.

This was awarded to the Georgia cotton producer with highest loan value and premium. The 2017 Best Cotton Award went to Robert Rawlins with a loan value of 54.14 cents/lb and a premium of 4.65 cents/lb.

No digging up of vegetation is permitted and stumps will be ground level with the surface. Removal will be done by hand inside wetlands. Land disturbing equipment is not allowed in those areas.

## State route right of way maintenance underway for safety and function

Anyone living in Southwest Georgia last January likely remembers the tornadoes and straight line winds that left behind piles of debris, much of it on roadways.

"State Route 91, where the big oak trees were, it took a full day to get the road open. We only had one lane open down there for probably 18 hours. There were sections of SR 520 Business closed because power lines were down, mainly because trees fell on them. It was closed for at least three days," said Jerry Wayne Smith, Georgia Department of Transportation assistant maintenance engineer for the Albany area.

Emergency responders need clear roads after extreme weather events. It's one of the reasons Georgia DOT's Southwest District is contracting for the removal of trees and vegetation on the state route right of way. The maintenance is also being done for the public's safety. Colliding with a tree was the third most frequently reported fixed object crash in 2017. Vehicle vs. tree collisions resulted in 161 fatalities, 939 serious injuries and 1,325 visible injuries last year.

vegetation removal and has submitted four others for bid.

DeAngelo Brothers LLC is in the process of working on the right of way of SR 31 in Lowndes County from north of SR 7/Inner Perimeter Road to the Lanier County line. Work is expected to be complete March 1.

Lovin Contracting Co. Inc. was awarded a contract for vegetation removal on SR 122 in Lanier County from the Lowndes County line to west of Peachtree Street in Lakeland. Work must begin by Feb. 22.

Other vegetation removal contracts submitted for bid are for portions of SR 45 and SR 50 in Terrell County, SR 39 in Quitman County, SR 202 in Colquitt County and SR 202 in Thomas County. A contract for a portion of SR 31 in Lanier

County is expected to be submitted for bid soon.

GDOT representatives are meeting with local government officials before work begins in their areas.
