

Lanier Co. December voter turnout small

Following record voter turnouts for earlier elections, only a small number of Lanier County's registered voters turned out for our December 4th Secretary of State and a Public Service Commission (PSC) seat. 14% of Lanier County registered voters or 706 of 5,034 registered Lanier County voters cast their ballots in December's runoff election. They helped approve Brad Rafflesperger, Republican, as Georgia's new Secretary of State and re-elected Chuck Eaton, Republican, to a third term as a District 3 Public Service Com-

mission (PSC) member.

Eaton's election to a third-term PSC 3 seat should not be confused with the fact that our local State Representative Jason Shaw has been appointed to the District 1 PSC post as longtime commissioner Doug Everett retires and steps down at the end of the year. Recently, Shaw as appointed by Governor Nathan Deal to fill Everett's PSC position.
