Best, who also works at CHI Overhead Doors in Arthur, put out the word to local friends and his western buddies to come and take part in the inaugural event. "I was overwhelmed by the

response." The enthusiastic team gathered up the nine head of cattle and drove them three miles from the ranch to the Arthur Sale Barn and then drove them The event was not purely

just for fun either. Best, whose close friend and coowner of the cattle company in California, suffers from PTSD. Best wished to use this to raise awareness about the issue. "My friend

was supposed to be here but he was having some struggles and had to check in for outpatient treatment. He is impacted everyday by PTSD but knows when and where to seek help. There are so many people who have put their lives on the line in serving our country that are just like him. We need to find ways to support them!"

Best indicated that there would be another drive in the future.
