Mdc Offers Free Voluntary CWD Testing Statewide All Season

The Missouri Department Telecheck their deer before of Conservation (MDC) wants deer hunters to know that it is offering free chronic-(CWD) wasting-disease sampling and testing of deer harvested anywhere in the state throughout the entire deer hunting season - Sept. 15 through Jan. 15, 2019. The sampling is voluntary and hunters can also get free test results for their deer.

Hunters can have their deer sampled at 11 select MDC offices around the state. Hunters can also take their deer to 64 participating taxidermists and meat processors located in the 48 counties of MDC's CWD Management Zone. (See map for CWD Management Zone counties.)

Find locations and more information on voluntary CWD sampling at mdc. mo.gov/cwd under "Voluntary CWD Sampling All Season." MDC asks hunters to taking them to a CWD sampling location. Hunters can bring the entire deer -preferably field dressed -- or the head with at least 6 inches of the neck in place. Heads that have the cape removed for taxidermy can also be sampled.

CWD test results can take up to four weeks from the time of sample submission. Hunters can get test results for their CWD-sampled deer online at mdc.mo.gov/CWDTestResults.

MANDATORY CWD SAMPLING NOV. 10 AND 11 IN 31 COUNTIES


MDC will again conduct mandatory CWD sampling in 31 of the 48 counties of its CWD Management Zone during the opening weekend of the fall firearms deer season, Nov. 10 and 11. The counties include new ones added to the CWD Management Zone, counties with previous CWD positives, and counties very near previous positives.

The 31 counties for mandatory CWD sampling are: Adair, Barry, Bollinger, Cape Girardeau, Cedar, Cole, Crawford, Franklin, Grundy, Hickory, Jefferson, Knox, Macon, Madison, McDonald, Mercer, Moniteau, Ozark, Perry, Polk, Putnam, St. Charles, St. Clair, St. Francois, Genevieve, Stone, Sullivan, Taney, Warren, and Washington.

Hunters who harvest deer from these counties Nov. 10 or 11 must take their deer -- or the head with at least 6 inches of the neck in place -on the day of harvest to one of 61 MDC CWD mandatory sampling stations. Deer may be presented at any mandatory sampling station.

The CWD Management Zone includes counties within approximately 25 miles of CWD detections. Special regulations apply in these counties. For the 2018–2019 deer seasons, the CWD Management Zone includes Adair, Barry, Benton, Bollinger, Boone, Callaway, Cape Girardeau, Carroll, Cedar, Chariton, Cole, Cooper, Crawford, Dade, Franklin, Gasconade, Grundy, Hickory, Jeffer son, Knox, Linn, Livingston, Macon, Madison, Mercer, McDonald, Miller, Moniteau, Morgan, Osage, Ozark, Perry, Polk, Putnam, Randolph, Schuyler, Scotland, Shelby, St. Charles, St. Clair, St. Francois, St. Louis, Ste. Genevieve, Stone, Sullivan, Taney, Warren,

In Madison County, sampling stations will be located at the Barefoot Fireworks Store at Cherokee Pass.

If you cannot contact a Conservation Agent, you can call Operation Game Thief (OGT) at 1-800-392-1111. You can remain anonymous if you would like. Also, if an arrest is made you may be eligible to receive a reward. So, this season, while you are afield if you see a Wildlife Violation occur or you believe one has occurred please give OGT or your local Conservation Agent a call.

Retrieval of Game-If you kill or injure a deer or turkey, you must make a reason- able effort to retrieve and include the animal in your season limit. However, this does not authorize trespass. It is illegal to leave or abandon commonly edible portions of game.

The Conservation Department and the University of Missouri are working together to learn more about the survival, reproduction, and movement patterns of white-tailed deer. Their findings will be used to guide deer population models, disease management protocols, and localized deer manage

As part of this research project, male and female deer of all ages will be captured and fitted with GPS collars in four Ozark counties (Douglas, Howell, Texas, and Wright) and four northwestern counties (Andrew, DeKalb, Gentry, and Nodaway). The collared deer will then be released, and their movements and survival will be monitored. Deer also are being collared as part of a separate research project studying deer movements in southeastern Missouri (Bollinger Cape Girardeau, Stoddard, and Wayne counties).

During the hunting season, it is important to NOT let the presence of a collar influence your decision on whether or not to harvest a deer. If you normally would shoot a deer that happens to be collared, please do so. Likewise, if you normally would pass on a deer, please do not let the presence of a collar cause you to take a shot. If you harvest a collared deer, or one that has a small metal ear tag, please cal the number listed on the collar or tag as soon as possible For more information about these research projects,

Hunters Urges to 'Share the Harvest'

hungry Missourians. The National Institutes of Health state that children need protein in their diets for proper growth and development, and adults need it to maintain good health. Yet many Missourians can't afford or can't get to good sources of protein. Through Share the Harvest, Missouri hunters can help provide those in need with high-quality protein in the form of naturally lean, locally harvested deer meat.

Thousands of Missouri deer hunters donated more than 289,200 pounds of venison to the program last deer season including nearly 5,600 whole white-tailed deer. Since the program was started in 1992, Share the Harvest has provided nearly 4 million pounds of lean, healthy venison to help feed hungry Missourians.

The program works by deer hunters donating their extra venison -- from several pounds to whole deer -- to participating meat processors throughout the state who grind and package

the deer meat. The packaged venison is then given to local food banks and food pantries for distribution to Missourians in need of food assistance.
