 There has been a flurry of business activity on Main Street in Villa Grove recently. Main Street Treasures is settling into their new facility in the old Collom Shoe Store location. Sam Laws has purchased the old Slender You location for an as yet undisclosed purpose, and Picture It Sold, which specializes in online consignment sales and other services, has opened its doors in the space formerly occupied by MST. I recently caught up with Jamie of Picture It Sold to learn more about the latest venture to come to Villa Grove.

1. What is the name of your new venture?
 The name of the store is Picture It Sold, my son actually came up with the name after days of brainstorming! The reason for the name is that we take pictures of items and sell

them online and in the store. We are located at 6 N. Main Street in Villa Grove.

2. What services do you offer?
 We specialize in consignment both in store but especially online consignment. We take in items, photograph them and list them on eBay. Once the item sells we ship it to the buyer. We are also doing professional printing services, specializing in high quality invitations, flyers, business cards etc. all of the design work and printing is done right in the store! If you're in need of Vape supplies, for example electronic cigarettes and the liquid that goes into them "juice", coils and glass, we have an entire section of the store dedicated to that.

3. Have you seen a demand for these services?
 There is a high demand for online consignment. A lot of

people have valuable items that they no longer want but do not have the time or know how to sell them online themselves. Selling on eBay can be very time consuming and there is quite a learning curve involved not to mention the multiple accounts that need to be set up in order to get started. We take all of the work out of it for our customers. Just come in and drop the items off and we'll take care of the rest.

As for the Vape supplies, there is a demand, as it has become a popular alternative to smoking and we are the one of the only places within a 30 minute drive to get high quality supplies.

There is always a need for design and printing services, specializing in wedding invitations, bridal shower and baby announcements, business services etc., we have obtained a high end printer

and plan on keeping it busy!


4. What are some of the unique features of your services?
 Picture It Sold is the only consignment shop in town and the only online consignment shop in the immediate area. We have been able to get our consigners so much more money for their items than they would be able to get say from a garage sale or local "for sale" page or site. With eBay you have so many more opportunities to make the sale because of the large number of people shopping the site. We are offering some pretty unique items and have a lot of fun researching the various treasures people are bringing us and setting up the showroom - arranging and rearranging is something we do a lot of! The items people bring us are listed on eBay but are also in our store for sale for people who want to come in and shop.

5. Do you see future expansion opportunities?
 Yes, we will eventually open our back room up for larger local consignment items such as furniture, heavy equipment and such. We are doing holiday and seasonal themed items in the store to give our customers a chance to shop here in town. For example we are obtaining gently used Prom dresses for the upcoming prom season. We are asking people to bring in their dresses and we will showcase them in our store. We will also have an area set up so that you can try the dress on. For Halloween we will have unique costumes and of course we will be going all out for Christmas at the store!


6. Will you be adding services in the future? If so, what are they?
 We have thrown a couple of ideas out there, there is always room for change and we plan on evolving as we get new ideas and requests from our customers!

7. Is there anything that you would like to add?
 We are proud to have another business open on Main Street here in Villa Grove. It seems to be becoming quite a trend that I would like to see continue. We are officially open now and will be having a huge celebration for our Grand Opening on Saturday, March 31. There will be a lot of giveaways and food! We hope to see you there!

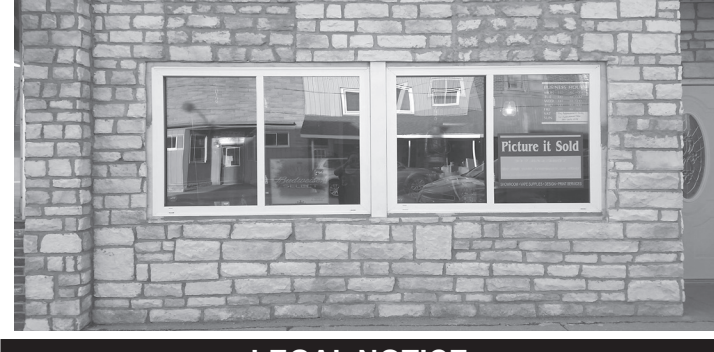
