RULES

- 1. The management reserves the right to bar any exhibitor from competition for misconduct.
- **2.** Every registered beef animal must have a readable tattoo.
- **3.** The superintendent of the division will have charge of the assignment of the space, and exhibitors will obey the rules.
- **4.** Check the general rules and regulations and health requirements found elsewhere in this section.
- **5.** For the Classes listed for each breed, there will be a Youth Show as outlined in Beef and Dairy.

4-H and FFA

- 1. Only members of 4-H Clubs and Future Farmers of America Chapters in Hancock County will be eligible to enter the Youth Division.
- 2. Showmanship classes will be divided by age.
- 3. During the youth show, all animals must be shown by members of 4-H or FFA.
- **4.** Club members must have projects started at least 90 days prior to show.

KENTUCKY LIVESTOCK EXHIBITION REQUIREMENTS

GENERAL PROVISIONS KENTUCKY LIVESTOCK

- 1. All animals, except as noted, shall be accompanied by a certificate of Veterinary Examination. Veterinary Examination certificates shall be void one hundred and fifty (150) days after issuance. A certificate of Veterinary Examination means a legible record covering the requirements of the state of destination accomplished on an official form of a standard size from the state of origin or an equivalent form of the Animal and Plant Health Inspection service, Veterinary Services, United States Department of Agriculture, that is prepared and issued by a licensed, accredited veterinarian.
- 2. If animals are from tuberculosis accredited or brucellosis certified herds, the certificates of Veterinary Examination shall show accreditation and certification number with date of last herd test for tuberculosis and brucellosis.
- **3.** Livestock infected with warts, ringworms or any infectious or communicable disease are not eligible for show.

GENERAL PROVISIONS OUT-OF-STATE LIVESTOCK

- 1. All animals, except as noted, shall be accompanied by a certificate of Veterinary Examination. A certificate of Veterinary Examination shall be void thirty (30) days after issuance. A certificate of Veterinary Examination means a legible record covering the requirements of the state of destination accomplished on an official form of a standard size from the state of origin or an equivalent form of the Animal and Plant Health Inspection Service, Veterinary Services, United States Department of Agriculture, that is prepared and issued by a licensed, accredited veterinarian.
- **2.** If animals are from tuberculosis accredited or brucellosis certified herds, the certificate of Veterinary Examination shall show accreditation and certification number with date of last herd test for tuberculosis and brucellosis.
- **3**. Livestock infected with warts, ringworm or any infectious or communicable disease are not eligible for show.

LIVESTOCK HEALTH REQUIREMENTS

All livestock/animals offered for sale or exhibition at Kentucky County fairs shall meet the following regulations according to KRS Chapter 257:

- a. 302 KAR 20:040 (Entry into Kentucky)
- b. 302 KAR 20:065 (Sale and Exhibition of Kentucky Origin Livestock) Any questions concerning these health regulations should be directed to your local veterinarian or the Kentucky State Veterinarian's office at 502-564-3956.
