

Boat Tours Resume at Everglades National Park

HOMESTEAD – Everglades National Park recently announced that boat tours will resume from the park's Gulf Coast Visitor Center on July 1. The National Park Service has awarded a temporary contract to Guest Services, Inc (GSI). The one-year contract has been issued through June 30, 2020.

GSI will provide narrated interpretive boat tours, departing from the Gulf Coast Visitor Center, four times daily. Beginning in mid-December, GSI will increase to six daily tours for the winter season. Additionally, the

concessioner is authorized under the temporary contract to provide small boat tours, retail sales, equipment rentals (canoes, kayaks, camping equipment), and guided canoe or kayak excursions.

"We are so pleased that Guest Services will be providing this service for our visitors over the next year," said Superintendent Pedro Ramos. "Exploring this area of the park by boat is a great way to experience the mangrove estuary that is such a vital part of Everglades National Park."

Later this summer, the National Park Ser-

vice intends to announce a business opportunity for a 10-year concession contract to provide the boat tour and affiliated services at Everglades National Park's Gulf Coast location.

A subsidiary of GSI, Everglades Guest Services, Inc., holds a 20-year concession contract for operations of the Long Pine Key Campground and the Flamingo Marina and Campground in Everglades National Park.

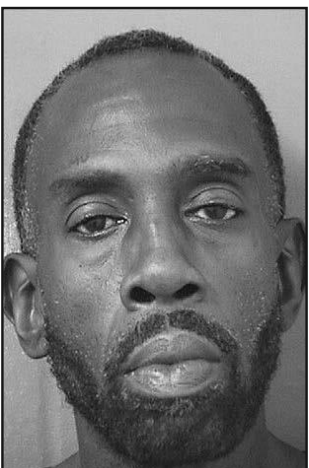
