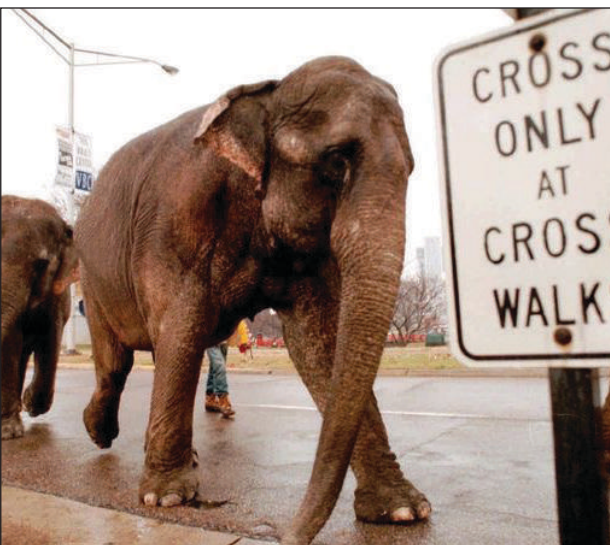


# The Circus

Being raised in the city every time spring comes around one of the things I remember the most as a young boy was when the Circus came to town. It was a big deal. As soon as I heard the circus was coming to town my mind went into overtime seeing all the animals and acts that were coming to town. As the circus wagons passed by, followed by elephants and tigers in cages, clowns riding in a small car and juggling to me what looked like bowling pins. The "Greatest Show on Earth" the Ringling Bros. and Barnum & Bailey Circus closed for good just what seems to be a few years ago on a Saturday night in New York, ending a 146-year run. They say that success has many fathers and failure is an orphan but in the case of Ringling, there is at least one proud papa taking credit for driving the circus into the ground and that is the animal rights movement.

The circus for wild animals came to an end when People for the Ethical Treatment of Animals in a news release after Ringling announced its imminent shutdown in January. "Thirty-six years of PETA protests and of documenting animals left to die, beaten animals, and much more, has reduced attendance to the point of no return."

The dwindling audiences that led Ringling to fold up its Big Top probably have had more to do with competition from other forms of family entertainment than with animal rights agitation. The Kill Ringling Brothers movement which includes many groups, among them the Humane Society of the United States, the American Society for the Prevention of Cruelty to Animals and the Performing Animal Welfare Society, as well as celebrities such as "Baywatch" star Pamela Anderson and "Family Guy" creator Seth MacFarlane was nothing if not dedicated. Someone should protest Family Guy. If you have never seen it you are missing nothing. PETA posted picket bearing protesters outside nearly every Ringling performance and flooded the Internet with disturbing videos showing helpless beasts shackled in chains, closely confined in cages, goaded with hooks and whips and vulnerable to infectious diseases in packed circus trains.

Ringling Bros. has always denied mistreating its animals. Feld Entertainment Inc., Ringling's parent company, paid a \$270,000 civil penalty to the Department of Agriculture to settle a PETA brought claim of violations of the federal Animal Welfare Act. Feld also agreed to compliance training for its handlers and veterinarians. In 2016, Ringling took elephants out of its shows altogether. The PETA motto sums it up "Animals are not ours to eat, wear, experiment on, use for entertainment, or abuse in any other way." For the true believers, the idea is any use of an animal by a human is abuse.

I don't believe in cruelty to animals either but in some way it looks like things have gone to far the other way now. I respect a person's view on not eating meat or using animals to perform so why push their belief on everyone else. Once again in a small way between the Circus mistreating the animals and this countries move to political correctness ended what was once truly "The Greatest Show on Earth I miss it! Alex Berenson is a journalist and author of "Tell Your Children: The Truth About Marijuana, Mental Illness, and Violence." "Almost everything you think you know about the health effects of cannabis, almost everything pot advocates, and the media have told you for a generation, is wrong."

In truth, marijuana is too weak a painkiller for people who need opiates. 3) Deception: Pot is safe and a potential treatment for psychiatric problems like depression. Wrong again.

Berenson said, " .... a mountain of peer-reviewed research in top medical journals shows that marijuana can cause and worsen severe mental illness, especially psychosis. ("Psychosis" refers to a range of conditions that affect the mind, in which there has been some loss of contact with reality.)

So why the big push for marijuana to be legalized? Plain and simple: Money, money, money. There's potential for huge amounts of money to be made. For marijuana to be legalized, advocates have to put a positive spin on the product. The first step is legalization for medical purposes. When that's accomplished, then comes the push to get it legalized for recreational purposes. Just

like legalizing anything that will have harmful effect on families and children, advocates stifle the truth, attack the opposition, and paint a utopian picture. The only thing that matters is the money to be made!

Christian Persecution on the Rise Worldwide. More than 245 Christians around the world are now suffering "high" to "extremely high" persecution, according to Open Doors 2019 World Watch List. This is 14% higher than 2018. Open Doors believes this extreme rise in persecution is largely driven by Islamic extremism and Communist authoritarianism. Around the world every month: 225 Christians are killed. 104 are abducted. 180 Christian women are raped, sexually harassed, or forced into marriage. 66 churches are attacked. 160 Christians are detained without trial and imprisoned. The Barnabas Fund helps Christians in over 60 countries, when disaster strikes and they are forced to leave their

homes. In many cases, they are denied state aid ... purely because of their faith. Supplies to displaced Christian families included sacks of maize, blankets, sleeping mats and soap.

One more thing: "Coastal Cat. For nearly 40 years, residents along France's Brittany coast have been picking up novelty Garfield telephones from off their beach. The problem began in the early 1980's when orange phones designed to look like the famous cartoon character began washing ashore now and again. At first, it seemed to be a prank, but after 35 years, volunteers with an anti-litter group decided to find the source of the now-vintage Garfield phones. Recently, the mystery was solved: a lost shipping container broken open inside a sea cave accessible only during low tide. The container remains out of reach, meaning the Garfield phones will likely continue appearing on French coasts."
