

A much anticipated topic on the agenda was the Lake Cumberland Recreation Easement that was requested by Lake Cumberland Marina for utilities. Several local citizens spoke against the easement, voicing their concerns of the economic impact to the area as well as creating problems for anglers that fish Wolf Creek. The resolution was voted on and passed 3-2 with Magistrates Terry Waddell and Larry Holt voting no. According to Judge-executive Gary Robertson, merely passing the resolution does not approve the easement as only the Corp of Engineers can give final

Sheriff Derek Polston addressed the Court regarding issues in the payment of mileage for inmates transporting to the Judicial Center for court appearances. He also questioned the Court on the possibility of the Sherriff's Department receiving an allotted percentage of the ABC funds to use at their discretion. It was decided that further information would need to be obtained with County Treasurer Kim Fenske agreeing to speak with

The second reading of Ordinances 19-03 Budget Amendment and 19-04 2019-2020 Fiscal Court Budget & Recurring Expenses was heard and approved by the Court.

The Court approved the transfers of \$3,264.00 from the General Fund to Grants for VOCA Grant as well as a transfer of \$141,999.40 from Grants to the General Fund.

A motion was made to pursue the recycle rolloff truck lease with Kaco & Worldwide Equipment.

Judge-executive Gary Robertson appointed two individuals to the Amubulance Board: Michael Selby was appointed to replace Dr. Richard Perkins and Billy Grider was appointed to replace Chris Ferguson. They will join current Board member Randy Marcum, who was appointed last year.

Bids were opened from four companies for janitorial supplies with the Court accepting all of them in order for the Court to keep the option to purchase items at the

best cost from each sup-

plier.

Bids were opened and approved fuel, oil, chip & seal, hot mix, blacktop, pothole patch, rock and tile. Approved companies included Hudson Materials, Selby Asphalt, Gaddie Shamrock and Southern Petroleum of Somerset. The Court also retained the option to purchase various materials at the most affordable price.

The Court approved to proceed with the bid process for repairs for the D. Mann Road slide project as well as the Logan Antle Road Bridge project.

Logan Antle Spur Rd. was accepted into the County road system.

Preapproval was voted on for payment to the Library when flood control money comes in.

Jailer Bobby Dunbar presented the court with the April RC Dentention Center report. The receipts totaled \$84,336.85 and expenses were \$172,779.26. The average number of inmates was 144 for the month.

Meetings are public and everyone is encouraged to attend. The next regular meeting will be held at the Russell County Courthouse on Monday, June 10 at 6 pm.
