What if, just for a day, you didn't have any contact with the outside world? You refused to check any of your 3 email accounts, Facebook including Messenger, no face-time, Instagram, Snapchat, plus, you turned off your computer, tablet and smartphone(s). Also, turn off Pandora and Sirius Radio and click off the television. Not sure many people could or would even try to Unplug. Families sit together with everyone on some device. We have become more comfortable texting rather than talking. Families communicate with one another from different rooms within the same house by texting - sometimes texting within the same room, having a private conversation from others in the room. We have become more comfortable - not talking to one another and that is especially true of the internet generation.

The "I-must-have-my-phone-with-me-at-all-times" mindset has become a real problem, there's now a name coined for the fear of being without your phone: nomophobia --- as in no- mo(bile) phone-phobia----- that rush of anxiety and fear when you realize you are disconnected- out of the loop with friends, family,

work and the world. This lack of connection can be the result of no connection, a dead battery, no minutes, forgetting your phone or worst of all: the horror of losing your phone. It's a really bad day if you forget your phone when you leave home. If you are like me, you will go back and get the device because there are so many things you can't do without your device: 1) Have access to phone numbers; we don't memorize any more so, I can't make a call even if I have another phone, 2) I can't stay in constant contact, 3) I might miss something really big, 4) I just found out I must have a phone --even on days off and vacation because there might be a problem that requires a decision.

Last week, I worked 6 days - my day job, several evenings counseling and teaching and a Saturday morning webinar. My family invited me to go riding with them (bikes and ATVs). When I finished teaching the webinar at noon, I was so ready to get away from everything. As we rode away from paved roads and away from civilization, I could feel myself relaxing in a way I hadn't in a while. In the woods, communing with nature, the pressure and stress

melted away. In that completely technology free space, I could hear the creek flowing over rocks, the wind moving through the trees, the birds and my thoughts! As a child, my mother would often say to my rowdy siblings and myself, "I can't hear myself think". I finally understand. In silence, you can hear your thoughts. If we can pull ourselves away from technology, we can discover something new in the pause—a still small voice sharing the information that truly matters.

My hope for you is that you will make a conscious decision this weekend to turn off the devices, actually speak to and have eye contact with the people you love. And listen to them speak. Communication is an art and my hope is that we are not slowly losing this ability.
