Family relationships are

complicated and, if that were not enough, they are ever changing, ever evolving through developmental cycles and altered through divorces and death. Families are in a constant state of flux and reformation through life events. In a society of constant change, families move from their home community and families are further fragmented. Just when a family reaches homeostasis, consistency, and, possible complacency, something or someone changes everything – and we start the process to bring the family back into bal-

The social, emotional, intellectual developmental stages are the predictable transitions from childhood to senior adulthood. Throughout the lifespan we grow within the family system. The family life system, challenges, supports and aids in the transition to the next stage in the cycle. Without challenges, the family system tends to stagnate. It is through the challenges, faced within the system where family members to grow, change, rebuild and mature with new skills to face the next set of life cycle changes.

Erik Erikson (1959) postulated growth-related stages where the mastery of skill sets and developmental stones allow for successful transition from one stage of development to the next. If one does not master the skill set, theoretically, you may still move to the next phase of the cycle, but more likely to encounter social anxiety, difficulty with relationships and future adjustment without intervention.

experiences through the family system will affect personal perspective and success. Erikson claimed we all inadvertently ence "crisis and intrapsychic conflict" when faced with developmental tasks. Developmental crisis, challenges and conflict can be a painful and prolonged process. Ultimately, the developmental cycle is dependent on the distress, discomfort, discomposure and discombobulation for the necessary outcome - growth and metamorphosis the next developmental

"Feelings of worth can flourish only in an atmosphere where individual differences are appreciated, mistakes are tolerated, communication is open, and rules are flexible -- the kind of atmosphere that is found in a nurturing family" ginia Satir
