Free income tax prep available beginning Feb. 5

SPECIAL TO THE R-H

Free assistance with income tax preparation is available for residents of Green, Taylor and surrounding counties from the American Association of Retired Persons Foundation Tax-Aide program.

Electronic filing will be available free of charge. AARP membership is not required for assistance.

The counselors are retired business people with considerable experience in tax preparation. This year's counselors are Brenda Cook, Carolyn Scott, Kathy Curry, Beverly Edwards and Bettie Jo Russell.

AARP tax aide volunteers will assist taxpayers on a first-come, first-serve basis for anyone at their walk-in location each Tuesday from 10 a.m. to 4 p.m. CST. Priority will be given to senior citizens. Some tax preparations such as farm income and clergy are out of scope and counselors are not trained to assist these taxpayers.

They will begin Feb. 5 and conclude on April 9 at the Greensburg Cumberland Presbyterian Church, 699 Old Hodgenville Road, Greensburg. Other times may be available by appointment, call Brenda Cook at 270-932-7459.

VERY IMPORTANT: Persons using the service need to bring the following materials with them: PHOTO identification, SOCIAL SECURITY CARDS for the taxpayer, spouse, and dependents; copies of last year's federal and state tax returns; as well as all W-2's, 1099's, Interest Income, Dividend Income and any other relevant materials showing their income, expenses, etc., for the 2016 Tax year.

Because of the Affordable Care Act additional forms and information will be needed to complete income tax returns. The additional information needed is as follows: Forms

1095-A, B or C, Affordable Health Care Statements; health insurance coverage information for taxpayer, spouse and all dependents; if anyone on the return did not have the required coverage for the full year, information on monthly coverage is required. If an exemption was granted

by the IRS or Marketplace/Exchange, the form or letter granting the exemption, and all information needed to complete return for taxpayers, spouse and for each dependent that has a filing requirement must be brought.

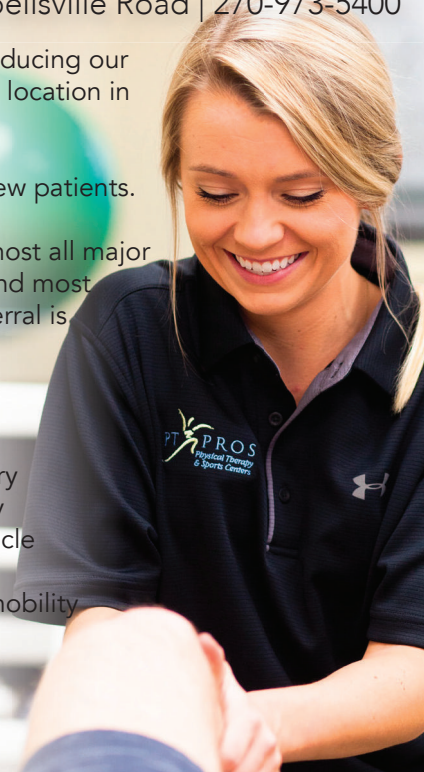
