Green County High School Senior Dalton Green's involvement with Rotary began some three years ago when he became a charter member and officer of the local high school Interact Club, which is Rotary International's youth organization.

His active status has provided him with numerous opportunities in his exposure to Rotary.

Presently, Green has initiated two projects that directly involve Rotary.

He said, "Because of my internship with Otha Ray and Nancy Stearman in their accounting firm, I have been actively immersed in a number of Rotary projects."

The GCHS senior is currently working on a project with Allen County-Scottsville High School, aiding them in establishing an Interact Club at the

Green said that the Interact Club is sponsored by the local Rotary Club and is a self-operating youth subset of Rotary which prescribes to the same goal of "Service Above

with the downtown Louisville Rotary Club in establishing a Rotaract Club for the University of Louisville. The University is one of his options as to where he will attend college this fall.

Rotaract, Green said, is a Rotary-sponsored organization for young adults, ages 18-30, which allows them to exchange ideas and work alongside members of Rotary.

"Previously, the Louisville Rotary Club had sponsored a failed Rotaract Club for U of L, but I believe with the work I have done with Rotary this year, I have the knowledge and background to make the University of Louisville Rotaract charter successful," he

Commenting on his future goal, the lo-

cal high school senior said, "With Interact at ACSHS and Rotaract at U of L, I am hopeful that each club will become self-sufficient in the 2019-2020 Rotary

These two organizations will be among approximately 23,000 Interact or 11,000 Rotaract Clubs worldwide.

Green hopes to obtain positive results from his projects.

He noted that Rotary adheres to the motto of "Service Above Self," but they also have a secondary motto which reads, "He Profits Most Who Serves Best.'

Green said, "Personally, I hope to obtain self-satisfaction in ensuring two additional Rotary-based clubs in District 6710.

Talking about his future plans with Rotary, the GCHS Interact member said, "I have been able to truly see what Rotary is all about and in short, my future plans would be to work alongside Otha Ray in his District Governor year to help establish and promote successful Rotaract and Interact Clubs throughout District 6710."

Referring to the progress made with the establishment of an Interact Club at Allen County-Scottsville High School, Green said, "I have met with Superintendent Randall Jackson, Career and Technical Center Principal Joseph Cosby, multiple teachers, and Scottsville Rotarians. We are currently in the process of doing the groundwork to establish a much-needed Interact Club for Allen County-Scottsville High School students."

With reference to an active University of Louisville Rotaract Club, he said, "I have been communicating back and forth via phone calls and emails with multiple members of the downtown Louisville Rotary Club. We are currently working on reestablishing the charter by the fall semester of 2019 at U of L. This will allow us to get a head start on recruiting members."
