dynamic, no matter what it may be, and how thankful youth should be that they have families.


"Today's generation is facing unparalleled hurts, pressures and choices, Dabbs says. "If we can heal

## Widespread flu reported for 10th consecutive week

The Department for Public Health, within the Cabinet for Health and Family Services, reports flu activity in Kentucky is at "widespread" for the 10th consecutive week.

Widespread is the highest level of flu activity, indicating increased flu-like activity or flu outbreaks in at least half of the state's

"With the traditional flu season running from October through May, it is not too late for Kentuckians to protect themselves and their families from the flu by getting a flu shot," said Dr. Jeff Howard, DPH Commissioner. "We are urging anyone who hasn't received a flu vaccine, particularly

children 6 months and older and those people at high risk for complications related to the flu, to check with doctors' offices, local health departments, pharmacies or other providers

about getting the vaccine." Kentucky is currently reporting 44 flu-related deaths for the 2018-19 flu season. For the 2017-18 flu season, Kentucky reported a total of 333 flu-related

It takes about two weeks after the getting the shot for a person to develop protection from the flu. Flu can be very contagious. Infection with the flu virus can cause fever, headache, cough, sore throat, runny nose, sneezing and body aches.

### **Cundiff** is formally charged with murder; 9 indictments

A Green County Grand Jury formally indicted a Green County man in the Jan. 5 death of his fatherin-law last week.

Robert L. Cundiff Jr., 32, 844 Ralph Vaughn Road, was indicted for murder at the March 6 Grand Jury session. The Grand Jury returned a two-count indictment in the slaying of Cundiff's father-in-law, Richard Gregory, at their Ralph Vaughn Road resi-

Police said a female in the residence called 911 reporting a fight and requesting an ambulance. Green County Sheriff's Deputy Adam Rainwater and Kentucky State Police Trooper Jon Houk arrived at the scene finding two females and one male outside the home. The suspect was found in the bathroom of the residence.

Gregory was found unresponsive with numerous head injuries in the basement of the home.

He was transported to Jane Todd Crawford Hospital where he was pronounced dead at 2:37 p.m.

Cundiff was also indicted on one count of tampering with physical evidence,

Bond was set at \$500,000. Cundiff and two females at the same address were also indicted on drug charg-

He, Sharon R. Gregory, 54,844 Ralph Vaughn Road, and Tamara A. Wright, 37, 44 Ralph Vaughn Road, were each indicted on one count each of trafficking in methamphetamine and possession of drug paraphernalia.

The charges stem from an alleged incident Jan. 5. Bond for Cundiff was set at \$10,000 and at \$5,000 each for Gregory and Wright.

Inother action, the March Grand Jury indicted:

Christina M. Graham, 34, 4635 Hwy. 566, Magnolia, on one count each of possession of methamphetamine, drug paraphernalia, DUI, no tail lamps, failure to produce insurance card and no seat belts.
