The training involved four scenarios including: car accident entrapment and extrication, tractor rollover entrapment and recovery, grain entrapment and extrication, and a dozer and log exercise involving entrapment Price. and extrication.

He said, "The benefits of having the training is to understand every person's abilities and to show our newest members the training that is needed for their certification and to be a more efficient fire and rescue service for our community."
