# **Board recognizes five at meeting**

The Green County Schools Board of Education met in regular session Thursday, April 11 at the central office.

A public hearing on District Facilities Plan was held prior to the regular meeting. The DFP was reviewed by the superintendent to Board members. The plan pertains to the future of facility needs in the District.

The Board recognized a student, community member and three district employees at the meeting.

Green County High School senior Gracie Parrott was recognized for her service on the Dragon News Team.

During her involvement with the Dragon News Team, Parrott would host segments on local radio stations to provide weekly broadcasts of important events and news related to Green County Schools. The board highlighted Parrott's excellent work and thanked her for being a positive public relations ambassador for the district.

Local resident and long-time locksmith, Bob McCrary, was recognized for his many years of service to the district. McCrary has been a fixture in the Greensburg community and has serviced numerous individuals and businesses with his locksmithing capabilities over the years. Although he semiretired from his business several years ago, McCrary continued to assist Green County Schoolswithlocksmithing needs. McCrary recently announced his full-retirement and the local board of education wanted to recognize him and express their gratitude for his dedication and service to the district.

Two district employees, Ms. Jamie Vaughn and Ms. Debbie Mills, received the board's prestigious "Above and Beyond" Golden Apple Award.

Vaughn, a teacher at Green County Middle School, and Mills, an instructional assistant at the middle school, were both nominated by parent, Marie Burns. Ms. Burns was in attendance for the recognition and made an emotional testimony thanking Ms. Vaughn and Ms. Mills.

The Board approved the hiring of emergency substitute teachers for the 2019-20 school year. This is a yearly need.

The Board granted approval of the grant application for the 2019 Kentucky Waste Tire Crumb Rubber and **Tire-Derived Products** grant totaling \$3,518. If awarded, the grant would be utilized at the Primary and Intermediate Schools to purchase two picnic tables and five benches made from recycled Kentucky waste tires. The District would be responsible for a 25%match of the costs.

The usage of Green County High School for the Kentucky Changers for July 3-11 was approved.

Superintendent Hodges reported on the continuation of Healthy Kids Clinic.

The retirements of Annissa (Buffy) Scantland, Missi Surratt, Tommy Davis, Debbie Thompson, Darlene Henderson and Nina Scott were approved by the Board.

Hodges reported the hire of a school psychologist, Kristina Rutlege. She will begin May 1.

The superintendent announced Governor's Scholars from Green County High School--Abby Knoy and Makayla Vaughn.

The next regular scheduled board meeting is set for May 9.

The Board will have a working session April 25 and a special-called meeting May 7.
