Recently, the park hung a sign on the little league softball field as a dedication to Bill Squires. The field was named the Bill Squires Field to honor and show an appreciation for his many years of anonymous support. His family has continued to be involved in the park from umpiring to playing.


FFA members also will have the chance to attend a variety of workshops that are

intended to help them become better leaders in the years to come. One keynote address will be given by educator and speaker Gian Paul Gonzalez. Gonzalez is best known for his "All In" speech to the New York Giants on Christmas Eve 2011. The speech is widely credited with propelling the Giants toward winning the Super Bowl in 2012. address attendees. Before the convention begins, almost 200 FFA members are expected to participate in a meal packing activity June 10 as part of the Kentucky FFA Day of Service. The group will pack about 30,000 meals for distribution by Love the Hungry, a Louisville-based group that provides meals to nongovernmental organizations that reach the world's most vulnerable children.

The convention will conclude June 13, with more than 480 members receiving the State FFA Degree. This degree is based on students' work-based learning projects through high school, as well as their involvement in FFA and community ser-
