Summer break is winding down for Green County students with opening day just a few weeks away.

Students will head back to school Wednesday, Aug. 7; teachers go back Tuesday, Aug. 6.

Back-to-School Festival planning is in high gear within the District with pre-registration events starting as early as next week.

Since majority of registration can be done online this year, both Green County Primary School and Intermediate School will have a two-day pre-registration window next Monday and Tuesday, July 22-23, from 12 to 6 p.m. CT each day. The come-and-go process is beneficial to getting everything done for those with busy schedules who want to bypass the first week of school paperwork. Students who are preregistered at either school will be entered in a drawing for a chromebook. Green County Intermediate School principal Donna Young invites all primary/ intermediate school parents to participate in early registration at their respective school locations. "Early registration is a great opportunity to get a head start on the important forms needed to assist in meeting student

needs throughout the year," Young said. "[At GCIS] The computer lab will be set up for online forms and the library for written forms which will include student health forms, infinite campus parent portal, Parent Teacher Organization signups and Parent Volunteer forms."

"Please remember to bring insurance cards, social security numbers and numbers/ names of those you want on your student pickup lists," she said. "I hope to have a large turnout and look forward to meeting parents and students.'

Students at all schools will get the opportunity to meet their teachers, view classrooms, and obtain supplies from community members. The GCIS festival is set for Monday, July 29. Third grade students should attend at 4:30 p.m., with fourth and fifth grade students arriving at 5:30 p.m. CT. The primary school back-to-school festival will be held Tuesday, July 30 from 5 to 7 p.m. Kindergarten will begin at 5 p.m. with first and second grades following at 6 p.m. Green County Primary School PTO is once again purchasing all of the students' school supplies, with the exception of a back-

The Green County 10U All Star Cal Ripken team claimed the State Championship Title Sunday afternoon.

The 10U team ended their District Tournament as Runner-Up. This past weekend they returned to their home park for the State Tournament. As teams filtered into the park, it was evident Green County was not the biggest team, but they held a no-quit attitude throughout the tournament. In the first pool play game against Meade County Wednesday the Green County Dragons came back in the fifth inning from a 9-2 deficit to tie the game at 9. The team would fell short in the final inning as Meade scored 7 runs. Final score was 16 to 9.

They returned the next day to defeat Henderson County 1-6 in their final pool play game.

The state tournament kicked off Saturday with Green County taking on longtime rival LaRue County. The team shut-out LaRue County with a 7-0 win. The squad returned to the diamond later that evening and out-bat Breckinridge County for the 11-7 win.


