"The event is to encourage WIC recipients to use their vouchers," Green County Health Educator Jackie

Hodges said. "In 2017, the percent of WIC recipients that actually used their vouchers was 25 percent, which could have kept Green County from receiving more vouchers in the future."

To those eligible, pick up a WIC Farmers' Market Food Instrument and spend it at the market. Food instruments are limited in quantity-first come, first serve.

"Wednesday's event will happen rain or shine and is open to the public," Hodges said. "Customers do not have to be WIC participants."

State updates proposed tattoo regulations

The Cabinet for Health and Family Services has filed an updated proposed administrative regulation, outlining requirements for tattoo studios in Kentucky.

In the process of drafting the regulation, the cabinet received more than 600 public comments. This input helped to inform the decision-making process and ensure the regulation was appropriate for modern industry standards.

After further analysis, the Cabinet chose not to move forward with the portion of the proposal that prohibited tattooing over scarred skin.

The intent of the language prohibiting

the tattooing of skin that is scarred should have been to prohibit the tattooing of freshly scarred skin. However, that part was left out of the filed version of this administrative regulation. The Cabinet agrees there is a lack of available evidence to support this prohibition.

"We truly appreciate the valuable input from the public in the regulation review process," Dr. Jeff Howard, Commissioner of Kentucky's Department of Public Health, said in a state news release. "Based on comments received, we elected to remove the language relating to scar tissue."

Under the new rules, a person registering as a tattoo artist will have to complete a blood-borne pathogen training. The Cabinet has

also updated the disinfectant and equipment sterilization process.

The registration process for a tattoo studio is outlined in the regulation, with increased fees to offset the inspection cost.

Finally, the new regulation will require a notarized statement of parental consent for a minor seeking a tattoo without a parent or legal guardian present.

Here is a summary of changes found in the "Amended After Comments" version of the regulation:

Removes the prohibition against tattooing over scarred skin
Updates definitions for autoclave, disinfectant, hand-washing and sterilization
Specifies that a studio using all disposable products is exempt from

the clean room and autoclave requirements

Updates the record keeping procedures to allow for more modern procedures

Revises the requirements for a temporary event license and workstation size.

The cabinet has filed the updated regulation with the Legislative Research Commission. The amendment will be on the agenda at the Administrative Regulation Review subcommittee meeting in August.

Projects submitted to the Department of Rural and Municipal Aid for discretionary fund consideration were evaluated by the KYTC district staff to assess the condition of roads and determine the most critical needs based on factors such as safety, economic impact, and traffic volumes.

"I'm pleased to hear that Green County has received funding for these resurfacing projects," said Sen. David Givens. "Having safe and dependable roadways will no doubt benefit our community."

Rep. Brandon Reed, also applauded the importance of the upcoming repairs.

the state make resurfacing these roads a priority so that the families who travel them every day will have a safer, smoother ride," said Rep. Reed. "Maintaining our roads has to be a priority. If we don't maintain them, we'll have to replace them."

The Green County Fiscal Court is responsible for administering the work, and KYTC will reimburse the county for the projects.

- Bramlett-Kemp Road (County Road 1142) from milepoint 0.00 to milepoint 0.593
- Bramlett-Kemp Road (County Road 1142) from milepoint 1.048 to milepoint 2.099
- Despain Road (County Road 1342) from milepoint 0.00 to milepoint 1.063
- Old Caven Bend Road (County Road 1281) from milepoint 0.00 to milepoint 1.347
- Aetna Grove Church Road (County Road 1366) from milepoint 0.00 to milepoint 1.792
