# Gov. Bevin's pension-relief bill passes in a close vote

Gov. Matt Bevin's bill to provide pension relief to regional universities, health departments and other "quasi-governmental agencies" passed a crucial test on Monday when members of the Kentucky House approved the plan 52-46.

The General Assembly is meeting in a special legislative session, which Bevin called last week in order to pass the bill.

The House vote came after three hours of debate. The bill now goes to the Senate for a vote.

On Saturday, the

House State Government Committee approved the bill on an 11-8 vote over objections of Democrats who warned it is likely to slash pension benefits anticipated by a few thousand public employees.

Also Saturday, state Attorney General Andy Beshear, who is running for governor against Bevin, said the bill may be susceptible to a court challenge because Bevin's call for the special session was too restrictive.

"... The constitution limits the governor to outlining the topic or the subject that may be consid-

ered — not the exact terms that the legislature must adopt," Beshear said Saturday.

Bevin's office discounted Beshear's claims, noting the legislature's option of adjourning without passing the bill if its members aren't convinced of the bill's merits.

Bevin's bill, House Bill 1, would give the affected agencies a one-year delay in paying much-higher pension costs, which went into effect July 1.

The bill also gives these groups options for paying off their liabilities to the troubled state pension plan and getting out of it.


