"My favorite race so far this year was a race in Whitesburg, Kentucky," Young said. "That was about a four-hour drive for us, but it was for coal miners who had lost their jobs in the mines of Eastern Kentucky. That was a night race and the people were there were very nice to us and very appreciative of us being there to run."

Young plans to continue running even after he has reached his goal of participating in every county.

"I'm really enjoying it now," he said, "and it has become part of my life. After I run in all counties, I want to focus on running in races that I just want to do."

Young trains every day by running at least two miles from his home in Newt. He used to run a 5K as part of his training every morning but now that he is in better shape, he has cut down on the number of miles he runs every week.

"Every morning before work," Young said, "I run two miles and then come home and eat breakfast and get ready for work. I sometimes run to the old

Pierce School and back which would be about 3.1 miles."

Young's next race is this weekend in Marion, Kentucky in the Crittenden County Pumpkin Festival 5K Walk/Run. That will be yet another county that he can mark off his list.

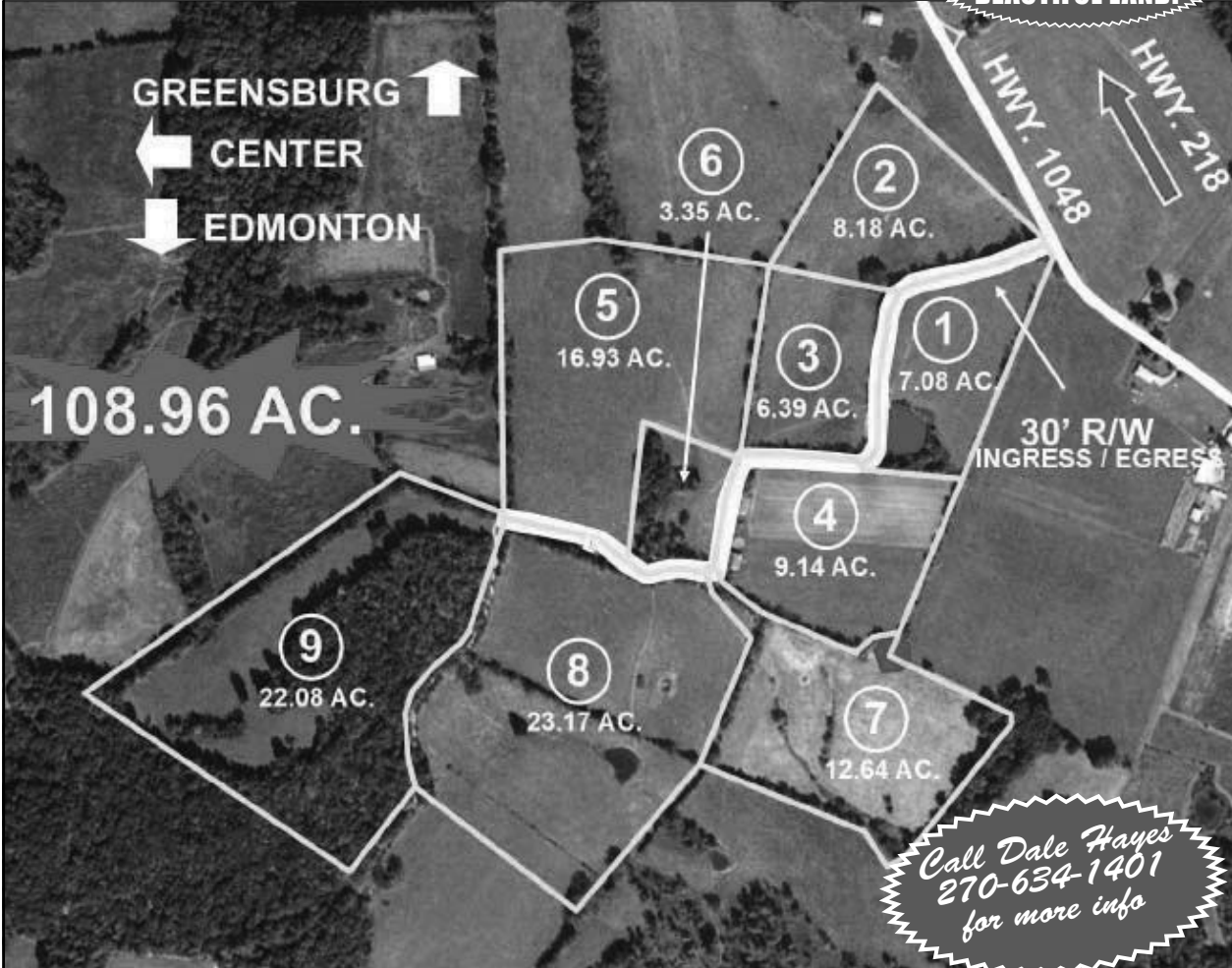
