

It's time: Health officials urge flu vaccinations

The Department for Public Health (DPH), within the Cabinet for Health and Family Services (CHFS), is encouraging Kentuckians to get vaccinated against the flu, as the official flu season begins Sept. 29 and runs through May 16, 2020. DPH officials are reporting 154 laboratory-confirmed flu cases in regions across the state since Aug. 4. “Getting the flu can be debilitating and sometimes life-threatening,” said Dr. Angela Dearing, Commissioner of DPH. “Vaccination is the best tool we have to prevent the flu. It is also extremely important to take simple preventive steps to avoid the flu and other illnesses that tend to circulate at this time of year – wash your hands frequently, cover your mouth when you cough or sneeze and stay home when you are sick.” Infection with the

flu virus can cause fever, headache, cough, sore throat, runny nose, sneezing and body aches. Flu can be very contagious. It takes about two weeks for the vaccine to become fully effective, so it is very important to get the flu shot as soon as possible. The Centers for Disease Control and Prevention (CDC) Advisory Committee on Immunization Practices (ACIP) recommends flu vaccine for all individuals six months of age and older. People who are strongly encouraged to receive the flu vaccine because they may be at higher risk for complications or negative consequences include: Children age six months through 59 months (less than 5 years) Women who are or will be pregnant during the influenza season Persons 50 years of age or older Persons with ex-

treme obesity (Body Mass Index of 40 or greater) Persons aged six months and older with chronic health problems Residents of nursing homes and other long-term care facilities Household contacts (including children) and caregivers of children aged ≤59 months (i.e., aged <five years, particularly contacts of children aged <six months) and adults aged ≥50 years Household contacts and caregivers or people who live with a person at high-risk for complications from the flu Health care workers, including physicians, nurses, and other workers in inpatient and outpatient-care settings, medical emergency-response workers (e.g., paramedics and emergency medical technicians), employees of nursing home and long-term care facilities

ties who have contact with patients or residents, and students in these professions who will have contact with patients. The flu vaccine has been changed to better protect against the types of flu that were seen last season. Adequate supplies of flu vaccine are expected to be available for this year's flu season. Vaccination can be given any time during the flu season, but providers are encouraged to administer the vaccine as soon as possible. The flu vaccine is especially important in light of the longest flu season the nation experienced last year. The CDC reports that more than 647,000 flu-related hospitalizations occurred and more than 61,000 people died as a result of the flu. In Kentucky, there were 194 flu-related deaths, two of which were children. It is especially important for pregnant

women to be vaccinated before or during pregnancy. Antibodies cross the placenta and provide immunity to infants up to 6 months of age, when the infant is eligible to receive their dose of flu vaccine. Last season in Kentucky, there were infants less than one month old that had the flu. DPH relies on sites such as doctors' offices, hospitals and health departments to help track the level of influenza activity in the state and to identify which strains of the flu are circulating in Kentucky. These voluntary sites collect data and report influenza-like illness (ILI) cases according to age groups each week. This sampling represents only a small percentage of influenza cases for the state, but contributes to the ongoing assessment of flu activity in the commonwealth and helps determine the weekly level of flu activity.

DPH officials report weekly influenza activity to the CDC as part of statewide flu surveillance efforts. The weekly report will be issued October 11, 2019 and posted online at <https://healthalerts.ky.gov/Pages/FluActivity.aspx>. The report will be updated by noon each Friday. The report consists of laboratory-confirmed cases of influenza that are defined by molecular virus testing and positive virus culture test results. Rapid positive influenza tests are not included in this report, but are used as an indicator of flu-like illness circulating across the state. LCDHD: Help to understanding mental illness

The purpose of the following information is to provide a general understanding of what mental illnesses are, and to address some facts associated with these disorders. What is mental illness? Mental illnesses are medical conditions that disrupt a person's thinking, feeling, mood, ability to relate to others, and daily functioning. Just as diabetes is a disorder of the pancreas, mental illnesses are medical conditions that often result in a diminished capacity for coping with the ordinary demands of life. Serious mental illnesses include major depression, schizophrenia, bipolar disorder, obsessive compulsive disorder (OCD), panic disorder, post-traumatic stress disorder (PTSD), and borderline personality disorder.

Mental illnesses can affect persons of any age, race, religion, or income. Mental illnesses are not the result of personal weakness, lack of character, or poor upbringing. Mental illnesses are treatable. Most people diagnosed with a serious mental illness can experience relief from their symptoms by actively participating in an individual treatment plan. In addition to medication treatment, psychosocial treatment such as cognitive behavioral therapy, interpersonal therapy, peer support groups, and other community services can also be

components of a treatment plan and that assist with recovery. The good news about mental illness is that recovery is possible. Some facts about mental illness: • Mental illnesses are biologically based brain disorders. They cannot be overcome through “will power” and are not related to a person's “character” or intelligence. • Without treatment the consequences of mental illness for the individual and society are staggering: unnecessary disability, unemployment, substance abuse, homelessness, inappropriate incarceration, suicide and wasted lives; The economic cost of untreated mental illness is more than 100 billion dollars each year in the United States. • With appropriate

effective medication and a wide range of services tailored to their needs, most people who live with serious mental illnesses can significantly reduce the impact of their illness and find a satisfying measure of achievement and independence. A key concept is to develop expertise in developing strategies to manage the illness process. • Stigma erodes confidence that mental disorders are real, treatable health conditions. We have allowed stigma and a now unwarranted sense of hopelessness to erect attitudinal, structural and financial barriers to effective treatment and recovery. It is time to take these barriers down. On a separate note, it is important to point out that Kentucky is one of the unhealthiest states in our na-

tion; but, a few healthy lifestyle choices could change this. First, eating normally proportioned helpings of nutritious foods including at least five fruits and vegetables a day can lower weight and reduce heart disease and diabetes. Second, exercising about 30 minutes per day can lower blood pressure. Third, avoiding the use of tobacco products can reduce several types of cancer. Finally, making sure you get your needed preventive screenings can detect diseases early and greatly increase your chances for a positive health outcomes, while receiving your recommended vaccinations can prevent acquiring disease in the first place.
