### MCFR Tech Rescue Team Performs High Angle Rescue

January 25, MCFR units were dispatched to the 6300 Block of Northwest Gainesville Road, Ocala, in reference to a patient who had fallen into the rock quarry. The 911 caller reported a person yelling for help who was stuck about 30 foot down on the face of a cliff.

The first of eleven MCFR units arrived on scene, established command, requested the MCFR Special Operations Technical Rescue Team and made patient contact. The patient had fallen into the quarry sometime Thursday evening and had climbed back up the face of the cliff. He was stuck on a ledge approximately 30 foot down.

The Special Operations Team arrived on scene, assessed the situation and determined a high angle rope rescue was to be performed. Technicians determined the safest anchor points and lowered "Rescuer #1" to make patient contact. The rescuer was able to assess and package the patient. Technical Rescue Specialists utilized Ladder 21's aerial ladder as a high point change of direction to bring the patient over top of the cliff.

The adult male patient was hoisted to safety, packaged and transported to a local hospital by our Critical Care Team. His condition is not known at this time.

### Ocala Woman Arrested For Child Neglect Due To Living Conditions

On Tuesday, January 22, 2019, MCSO Deputy Roy Johnson responded to a home in NW Ocala to assist the Department of Children and Families (DCF) with a child neglect investigation. Deputy Johnson made contact with the homeowner, Lee Stump (DOB: 10/15/1976), and a 13-year old juvenile who was also living in the home. Stump gave Deputy Johnson and the DCF investigator permission to enter the home, but said the house was a mess. Upon entering the home, Deputy Johnson said that he was hit with a strong odor of urine and feces. Multiple animals were in the home and their feces were all over the floor. Flies were also observed in the home, and dirty laundry and trash were everywhere. Deputy Johnson saw that the child was also dirty and was not wearing any shoes. The defendant claimed that she is disabled and that's why she can't clean the house. However, Deputy Johnson noted that she walked out of the house and got into the back of his patrol car without any assistance. DCF removed the child from the home and Marion County Animal Control took possession of the animals. Stump was arrested and charged with Child Neglect.
