During a legislative debate on Section 1303, then-Senator Ben Nelson (D-Neb.), restated what was clear from the language of the text itself: "You have to write two checks: one for the basic policy and one for the additional coverage for abortion."[2]

The Obama Administration undermined this requirement through subsequent regulations. Despite the plain meaning of the text, it interpreted "separate" to mean "together." The regulations stated that the requirement could be satisfied by "sending the enrollee a single monthly invoice or bill that separately itemizes the premium amount for non-excepted abortion services" and by not requiring the QHP issuer to "separately identify the premium for non-excepted abortion services on the monthly premium bill."[3] In other words, "separate" payments the could be made "together."
