

CPSD accepting residency documents in school, at Central Office

Students enrolling in Clinton's public schools must verify their residency in the school district.

To make the process easier, the Clinton Public School District will accept residency documents sent to school with their child during the weeks of May 13-24. The school will make the necessary copies and return the originals to the parent or the child.

For parents who are unable to get the required documents submitted before school ends, CPSD will be accepting residency documents during the summer in order to make the reg-

istration process easier in the fall.

Documents may be brought to Central Office at 201 Easthaven Drive from 8 a.m. to 4:30 p.m. Monday through Friday, from May 27 through July 26. The office will be closed on July 4.

To meet the residency requirement, parents or guardians must provide two proofs of residency. These can include ONE of the following:

- Mortgage document, or
- Lease agreement listing all occupants, including children, and expiration date, or
- Homestead exemption form, or
- Deed of Trust.

AND one of the following:

- Electric, gas, or water bill dated within the past three months, or
- Car tag registration, or
- Car title at the above address.

Those who do not own their own home or have a valid lease and are living with someone else in an affidavit situation will need to come to Central Office to prove residency on Tuesday, August 6, from 8 a.m. until 3:30 p.m. The documents listed above will need to be provided for the person with whom the enrollee is living. In addition, an affidavit form will need to be completed and notarized that day, and the following must be provided:

- A valid Mississippi driver's license or ID of the person with whom the CPSD enrollee is living,

AND one of the following:

- A utility bill in the name of the parent or guardian, dated within the past three months and at the address of the person with whom they are living, or

- Car tag registration in the name of the parent or guardian at the address of the person with whom they are living, or

- Car title in the name of the parent or guardian at the address of the person with whom they are living.
