# Fire guts home, but spares family

The fire that devastated the structure of the home at 933 E. Meadow Circle in the Woodlands Subdivision just north of Newville during the early morning hours of Friday, July 5, 2019, was not a total loss and was in many respects a triumphant story.

Triumphant because not a soul was injured, including firefighters, with every one of the five family members in the house being saved, plus the two dogs.

Triumphant because even though all five were fast asleep while the fire grew in intensity without any smoke detector going off, a fortunate combination of four citizens made heroic intervention victorious.

And triumphant because though the structure was a total loss, the lion's share of a valuable historical collection of civil war literature and memorabilia appears to be salvageable, at least according to Mark Boeche, who owns the home with his wife Stephanie.

On Saturday, July 6, the day after the conflagration, sitting in his truck in their driveway, looking a bit dazed after the day's long night, Boeche said, "I think, it could have turned out much worse. I'm thankful to the people who helped us in our time of need."

Those four people could well have been the difference between the relatively endurable disaster of a home fire and the unendurable tragedy of loved ones lost.

Edgerton Fire Protection District (EFPD) Fire Chief Randall Pickering, who was on-scene fighting the blaze, disclosed, "Two young women were driving along Maple Beach Road when they noticed flames over the rooftops of some of the homes in the subdivision and they went to see what was happening.

"When they got to where the fire was, they didn't see anyone in front of the house, or coming out. In fact, they didn't see anyone around. So, they laid on the horn and called 911 at 12:08 a.m.

"They were the original callers to 911."

Pickering said he was having the Dane County 911 Center track-down the caller because he wishes to recognize their critical help, along with the other two citizen responders, at a future EFPD meeting, as well as, he surmised, certain state firefighter conventions down the road.

"It just so happens," Pickering picks-up the thread again, "that two off-duty officers were relaxing on their decks at their homes. This was just after midnight. They went to find out who was honking the horn at that hour, saw the flames and responded. Meanwhile, other neighbors also called 911."

Boeche clarified, "Travis, who is with the state patrol, lives across the street and he kicked-in the front door. Andrew lives over on the corner of Prairieview and is with the state corrections department. He came in from the backyard and kicked-in the back door."

Fortunately, EFPD Deputy Chief Jason Russ also lives nearby, sharing, "I do live in that subdivision two blocks away and was on scene within a minute. I was incident com-

mand until Chief Pickering arrived."

Russ describes the eerie nocturnal scene, "When I opened up my garage door that night to respond, I was able to

see the orange glow and a very heavy smoke column already forming in the air.

"Upon arrival, the garage was well enveloped in fire and appeared to have been burning

for some time before we had been alerted. Prior to fire vehicles arriving on-scene the fire was able to breach the walls in

Steve's daughters, 20-year-old Bobbi and 13-year-old Izzi, were also at both events. "It's really become a family affair," Steve told the Golf Digest podcast. At the AmFam Championship weekend Steve said, "We love golf and we all play it. I enjoy having them out here. It brings us all together." All the women in the Stricker household have firsthand experience with competigolf. Nicki played collegiate golf for the University of Wisconsin and caddied for Steve on the PGA Tour from 1994-97. Since 2015 when Steve's caddie Jimmy Johnson left for Justin Thomas' bag, Nicki has been accompanying her husband "off and on.' "I think we would all come together regardless, but my family happens to center around golf," Nicki told thecaddienetwork.com a few weeks ago. "It started out not just with my grandfather but my uncle, my brother, my aunts." Nicki can now add "daughters" to that list of golf-enthusiast relatives. Bobbi is a 20-year-old red-shirt junior at the University of Wisconsin averaging 78.2 per round in four

## **Teacher** investigated for texts resigns By Jeff Brown

A male teacher at Edgerton High School who was investigated in April for sending text messages to a female high school student has resigned. The teacher's resignation was noted in a staffing report approved by the board of education at its June 3 meeting.

The following information comes from two police reports filed by Edgerton Police Officer Chilson on April 10 and 11, 2019. The Reporter has not named the teacher because he was not arrested or cited and has not named the student because she's a juvenile.

Dr. Mark Coombs, the high school principal, called the police on April 10. Coombs asked the police to participate in an investigation he was conducting into the behavior of a male teacher who worked at the high school.

Chilson went to the high school and meet with Coombs and Craig Lodahl, the athletic director/associate principal. They told Chilson that the male teacher had been suspended for three days pending an investigation into communications he'd sent to a female student.

Coombs and Lodahl had spoken to the student, several
