Nicholas Joseph Smith, (25), 213 NW 5th Ave, PO Box 332, Pennock, MN 56279

On September 11, 2018, at approximately 8:36 p.m., Deputy Stein received a report from BDS. BDS stated his son Nicholas Joseph Smith, the above named defendant, violated a harassment restraining order ("HRO") prohibiting contact with BDS. Deputy Stein obtained the HRO which was filed on February 15, 2018 and remains in effect until February 14, 2019. The HRO was signed by the Hubbard County District Court and prohibits the above named defendant from having any contact with BDS, including electronic and third party contact. Deputy Stein learned the above named defendant was personally served with the HRO on February 20, 2018. BDS informed Deputy Stein BDS is a Hubbard County resident.

BDS stated the above named defendant posted a review at approximately 7:30 p.m. on BDS' business's website. BDS showed Deputy Stein the above named defendant's post which was extensive. Deputy Stein observed the above named defendant state in the post that BDS drinks while on call for work and disparages his clients. Deputy Stein also observed the above named defendant go into great detail about BDS abusing the above named defendant in the past.

Upon reviewing the post Deputy Stein called the above named defendant. When asked whether he made the post the above named defendant stated, "It doesn't matter, I'm not taking it down." The above named defendant stated he had done nothing wrong by making the post but eventually agreed to take it down. After ending the call Deputy Stein received a call back from the above named defendant at approximately 10:42 p.m. on September 11, 2018. The above named defendant stated, "I'm going to hang myself now, have fun protecting rich a\*\*\*\*\*s from the consequences of being abusive" before hanging up.

On September 17, 2018 Deputy Stein received additional information from BDS. BDS stated the above named defendant had contact with the above named defendant's brother at approximately 8:19 p.m. on September 11, 2018 through text messaging. Deputy Stein obtained the text messages sent by the above named defendant stating, "Full story now added to [dad's work] reviews. I'll find more places to post it." The next text stated, "f\*\*k you, you sons of b\*\*\*\*\*s." The last test message stated, "I deserve so much more and so much better and I've needed help and it hasn't been there and everyone's turned the other way when I try to get help when I could have been there nobody give a s\*\*\* about me I'm going to go home and kill myself if you want to f\*\*\*\* bother dad about something you can bother me about why he has to bury his f\*\*\*\*\* sob because he can't face the truth of what the f\*\*\*\* he is." Deputy Stein verified with BDS that BDS is the "dad" in the text messages.

A check of the above named defendant's criminal history reveals a prior conviction for domestic assault on July 15, 2013 in file 02 -CR-13-4121 and gross misdemeanor domestic assault on February 22, 2017 in file 86-CR-16-4402.

James Lee Roper Jr., (25), 434 7th Street NW, Staples, MN 56479

On September 11, 2018 at approximately 11:09 p.m. Deputy Anderson conducted a traffic stop on Hwy 2 in the County of Hubbard after observing a vehicle, MN license plate 480MLH, did not have a working license plate light. Deputy Anderson approached the vehicle and spoke with the driver who he recognized as James Lee Roper. Deputy Anderson had previous contacts with Roper on August 19, 21 and 22, 2018 and was aware that his driver's license was revoked. Roper stated that he did not have identification with him and that he was unable to provide insurance for the vehicle. Deputy Anderson was aware that Roper was on probation for first degree controlled substance crime and subject to random searches and testing. While speaking with Roper, Deputy Anderson observed his eyes were bloodshot and watery and that Roper was shaking uncontrollably. On September 21, 2018, S/A Diekmann met with a confidential reliable informant (CRI) to conduct a controlled purchase of methamphetamine from Elizabeth Francine Glatzmaier, the above named defendant. The CRI informed S/A Diekmann the above named defendant agreed to meet at the Itasca Apartments and sell 1/4 ounce of methamphetamine for \$450. S/A Diekmann knew the above named defendant lives at Itasca Apartments.

The CRI stated the above named defendant approached the CRI's vehicle and informed the CRI she only had three (3) 1.75 gram bags left. The CRI stated he/she gave the above named defendant \$260 of pre-recorded buy money and the above named defendant gave the CRI the three (3) baggies of methamphetamine.
