# Court Proceedings

**Krista Michelle Wilson**, (40), 16766 Maiingan Wlf Rd., Cass Lake, MN 56633

On May 28, 2019, at approximately 12:39 a.m., Deputy Anderson was patrolling in northern Hubbard County, on US Highway 2, when he observed a vehicle traveling eastbound on Highway 2 with expired registration. Deputy Anderson observed the vehicle, a Ford Focus, displayed registration with an expiration of January 2019. Deputy Anderson activated his lights and performed a stop of the vehicle, in Hubbard County.

Deputy Anderson approached the vehicle and observed four individuals inside the passenger vehicle. Deputy Anderson identified the driver as River Shady. Shady stated he was only driving the vehicle because "she" was falling asleep. Deputy Anderson identified the front seat passenger as Krista Michelle Wilson. Wilson was identified as the registered owner of the vehicle. Deputy Anderson identified the backseat female passenger as Sarrell Jack and the backseat male passenger as Darryl Jackson Johnson. Deputy Anderson observed both backseat passengers to lack seatbelts.

While speaking with Shady Deputy Anderson was aware Shady's driving status was revoked. Deputy Anderson observed an open bottle of vodka, and alcoholic beverage, next to the backseat female passenger. Deputy Anderson observed the bottle of vodka to be approximately 3/4 full. While speaking to the parties Deputy Anderson observed Darryl Johnson to show signs of impairment by controlled substances. Johnson was fidgety and appeared to have a difficult time staying still. Johnson had a fast speech pattern and twitched constantly.

Deputy Anderson had the four occupants exit and performed a vehicle search of the Ford Focus. Deputy Anderson observed a black purse on the front passenger floor, directly in front of where Wilson was seated. Inside the purse Deputy Anderson located a micro baggie containing a crystalline substance. Deputy Anderson also located a large camera and camera film inside the purse. Deputy Anderson spoke with Wilson about the contents of the purse and Wilson admitted the camera, film, and methamphetamine belonged to her. The baggie was tested and weighed, testing positive for methamphetamine and weighing .49 grams.

Directly under where Darryl Johnson was sitting Deputy Anderson located a digital scale tucked into the seat cushion. Deputy Anderson believed Johnson was sitting on the scale in an attempt to conceal it. On the scale Deputy Anderson observed a white crystalline substance which tested positive for methamphetamine. Subsequently, Deputy Anderson located a rolled up one dollar bill in Darryl Johnson's pocket. The bill had a white substance on it which tested positive for methamphetamine. Johnson admitted he had consumed methamphetamine earlier in the day.

In the center console Deputy Anderson observed a small zippered case. Inside the case Deputy Anderson located two baggies containing a white crystalline substance, and twenty-five prescription pills. The prescription pills were all identified as 10 mg. Diazepam, a schedule IV controlled substance. The baggies were tested and weighed, testing positive for methamphetamine and weighing .66 grams. Wilson admitted the zippered case belonged to her but stated the illegal contents belonged to Shady.

A check of Krista Wilson's criminal history reveals a prior conviction for felony 3rd degree burglary on January 20, 2004 in file 04- K2-03-1098.

Count: 1 Drugs - 5th Degree - Possess Schedule 1,2,3,4 - Not Small Amount Marijuana; Penalty: 5 years and/or \$10,000.00

## Four invasive carp confirmed in Minnesota waters



### Latest fish captures do not indicate reproduction

The Minnesota Department of Natural Resources has confirmed the capture of a bighead carp (pictured right) and two silver carp, and detection of a third, tagged silver carp, within the past several weeks. The bighead carp was captured at the Xcel Energy King Power Plant in Oak Park Heights. All of the silver carp were in Pool 4 of the Mississippi River between Red Wing and Wabasha in southeastern Minnesota.



"The DNR has confirmed between two and seven individual invasive carp captures each spring since 2013," said DNR invasive fish coordinator Nick Frohnauer. "It is unusual that several of a single species would be captured in a short span of time. But, given the persistent high water this spring, this is not a surprise." Frohnauer noted that while the DNR continues to be very

concerned about the potential impacts of invasive carp in Minnesota waters, individual adult fish captures do not indicate reproduction or an established population of invasive carp in the Mississippi River or elsewhere in the state.

Persistent high water in southern Minnesota, Iowa and Illinois has created "open river" conditions in which fish can move upriver unimpeded by locks and dams. Open river conditions can benefit native species like lake sturgeon and paddlefish, which can swim hundreds of miles in search of preferable habitat. These conditions also allow other, non-native species to move upriver more easily.

A DNR telemetry array detected a silver carp in Pool 4 that was originally tagged much farther south, in Pool 16, in April 2017 by the U.S. Geological Survey (USGS). A silver carp was caught by an angler in Pool 4 May 24, and another was captured in Pool 4 June 4 by Xcel Energy. The bighead carp was captured on Thursday, June 20 during routine monitoring conducted by the DNR.

### Background

Fish telemetry in Minnesota started as a small sys-

tem to better understand fish passage at Lock and Dams 1 and 2 in the Twin Cities. The DNR expanded the system farther downstream and into the Minnesota and St. Croix rivers, to better understand fish movements in Minnesota's big rivers. The U.S. Fish and Wildlife Service (USFWS) then connected Minnesota's array with a Missouri array at Lock and Dam 19, in Keokuk, Iowa, in the southeastern part of the state. This Upper Mississippi array has been valuable in understanding large-scale movements of native fish and movement patterns of invasive carp.

In 2018, the USFWS provided funding for a dedicated invasive carp tracking crew to enhance Minnesota's telemetry project. This crew will work to find the invasive carp detected by the telemetry array. If the fish is located in Minnesota waters, the DNR will work with the USFWS and USGS to deploy nets and other sampling methods in the location of detection.

Invasive carp have been progressing upstream since escaping into the Mississippi River in the 1970s. These large fish compete with native species and pose a threat to rivers and lakes. No breeding populations have been detected in Minnesota waters. Individual invasive carp have been caught as far upstream in Mississippi River Pool 2 near the Twin Cities (bighead, grass, and silver), the King Power Plant on the St. Croix River by Oak Park Heights (bighead), and just downstream of Granite Falls in the Minnesota River (bighead).

The DNR Invasive Species Program has built partnerships with state and federal agencies, conservation groups, university researchers and commercial businesses to prevent the spread of invasive carp. The 2015 closure of the Mississippi River lock at Up-

per St. Anthony Falls in Minneapolis was a major accomplishment of these efforts.

The DNR is actively engaged with several prevention efforts.

The DNR is an active partner in the Upper Mississippi River Invasive Carp Workgroup. The group includes representatives from Minnesota, Wisconsin, Iowa, Illinois, Missouri, and several federal agencies.

In partnership with the DNR, the Minnesota Aquatic Invasive Species Research Center at the University of Minnesota is testing and evaluating carp deterrents in Mississippi River locks and dams. Previously, they had installed and evaluated a speaker system at Lock 8. Development of this technology will continue this year with the installation of an updated speaker system at this location.

The DNR's Fish and Wildlife Division leads a comprehensive sampling program to monitor fish population changes and impacts of management actions. This includes maintaining important relationships with commercial fishers and the angling public.









