### Pike Bay Police Chief Zeb Hemsworth

#### June Highlights:

• While patrolling back township roads, officer came upon a vehicle stopped in the roadway. Driver began to drive away and was stopped after officer recognized driver who had a revoked driver's license status and saw that

the vehicle registration was expired. Driver was arrested for driving while under the influence of controlled substances, possession of controlled substances and drug paraphernalia, and driving after revocation.

• Two kids were caught

wearing their helmets while riding their bikes. They were issued DQ ice cream citations (coupons).

• Officer responded to disturbance at a local business and arrested a male with warrants who attempted to evade arrest by hiding in the back of a vehicle. He was charged for fleeing.

• Officer made contact with several juveniles out during late hours. One of them, having arrest warrants, fled on foot and has been charged for fleeing.



### Cass County Attorney Ben Lindstrom

#### Cass County Attorney Ben Lindstrom reports:

Carlos Ramone Sargent appeared for sentencing in Cass County District Court on July 1, 2019. He was previously found guilty of being an ineligible person in possession of ammunition and had pled guilty to fifth degree controlled substance crime, fourth degree driving while impaired, and failure to appear. Given his criminal history, the Minnesota Sentencing Guidelines presumed a commitment to prison. Sargent was therefore sentenced to serve 60 months on the ammunition charge, 21 months on the controlled substance charge, and 19 months on the failure to appear charge. The

sentences run concurrently and he was given credit for time previously served. Law enforcement officers from the Leech Lake Tribal Police Department, the Cass County Sheriff's Office, and the Minnesota State Patrol were involved in the various investigations of these matters.

Clifford William Endriss appeared for a probation violation hearing in Cass County District Court on July 1, 2019. Endriss had previously been convicted of First Degree Controlled Substance Crime - Sale. The Cass County Attorney's Office negotiated a resolution whereby Endriss agreed to execute his 103 month prison sentence. He was given credit for 365

days previously served. Law enforcement officers from the Cass County Sheriff's Office and the Pine River Police Department investigated matters that helped the County Attorney's Office leverage this result.

Noah Steven Sovde appeared in Cass County District Court on June 20, 2019 for a probation violation disposition hearing. Sovde had previously been convicted of Fourth Degree Criminal Sexual Conduct. While on probation for this offense,

Sovde was convicted of burglary and domestic assault in Beltrami County. After these new convictions, the Cass County Attorney's Office requested that the Court revoke his probation and execute his 18 month prison sentence. This request was granted and Sovde was sentenced to serve 18 months in prison followed by a 10 year conditional release period.

## Court Proceedings

**Darryl Jackson Johnson**, (34), 31610 Woodbine Dr., Cass Lake, MN 56633 Amended Complaint

On May 28, 2019, at approximately 12:39 a.m., Deputy Anderson was patrolling in northern Hubbard County, on US Highway 2, when he observed a vehicle traveling eastbound on Highway 2 with expired registration. Deputy Anderson observed the vehicle, a Ford Focus, displayed registration with an expiration of January 2019. Deputy Anderson activated his lights and performed a stop of the vehicle, in Hubbard County.

Deputy Anderson approached the vehicle and observed four individuals inside the passenger vehicle. Deputy Anderson identified the driver as River Shady. Shady stated he was only driving the vehicle because "she" was falling asleep. Deputy Anderson identified the front seat passenger as Krista Michelle Wilson. Wilson was identified as the registered owner of the vehicle. Deputy Anderson identified the backseat female passenger as Sarrell Jack and the backseat male passenger as Darryl Jackson Johnson. Deputy Anderson observed both backseat passengers to lack seatbelts.

While speaking with Shady Deputy Anderson was aware Shady's driving status was revoked. Deputy Anderson observed an open bottle of vodka, and alcoholic beverage, next to the backseat female passenger. Deputy Anderson observed the bottle of vodka to be approximately 3/4 full. While speaking to the parties Deputy Anderson observed Darryl Johnson to show signs of impairment by controlled substances. Johnson was fidgety and appeared to have a difficult time staying still. Johnson had a fast speech pattern and twitched constantly.

Deputy Anderson had the four occupants exit and performed a vehicle search of the Ford Focus. Deputy Anderson observed a black purse on the front passenger floor, directly in front of where Wilson was seated. Inside the purse Deputy Anderson located a micro baggie containing a crystalline substance. Deputy Anderson also located a large camera and camera film inside the purse. Deputy Anderson spoke with Wilson about the contents of the purse and Wilson admitted the camera, film, and methamphetamine belonged to her. The baggie was tested and weighed, testing positive for methamphetamine and weighing .49 grams.

Directly under where Darryl Johnson was sitting Deputy Anderson located a digital scale tucked into the seat cushion. Deputy Anderson believed Johnson was sitting on the scale in an attempt to conceal it. On the scale Deputy Anderson observed a white crystalline substance which tested positive for methamphetamine. Subsequently, Deputy Anderson located a rolled up one dollar bill in Darryl Johnson's pocket. The bill had a white substance on it which tested positive for methamphetamine. Johnson admitted he had consumed methamphetamine earlier in the day.

In the center console Deputy Anderson observed a small zippered case. Inside the case Deputy Anderson located two baggies containing a white crystalline substance, and twenty-five prescription pills. The prescription pills were all identified as 10 mg Diazepam, a schedule IV controlled substance. The baggies were tested and weighed, testing positive for methamphetamine and weighing .66 grams. Wilson admitted

the zippered case belonged to her but stated the illegal contents belonged to Shady.

Both Darryl Johnson and Krista Wilson were transported to the Hubbard County Jail for controlled substance possession. Upon arrival Darryl Johnson was not cooperative with jail staff and refused to change into jail clothing. At approximately 7:25 a.m., C.O. Kahlstorf gave Johnson breakfast and required Johnson to change into jail clothing. Johnson was hesitant to remove his shorts and boxers but eventually did. While Johnson removed his shorts and boxers C.O. Kahlstorf observed a small micro baggie on the left side of Johnson's jail mattress with two rings belonging to Johnson. When C.O. Kahlstorf demanded the micro baggie Jail Sgt. Harris observed something come out from beneath Johnson. Jail Sgt. Harris demanded the item and Johnson immediately placed it in his mouth and started chewing. After a struggle jail staff was able to get Johnson to spit the bag and substance out and it was flushed. C.O. Kahlstorf then performed an additional search of Johnson, locating in the rear of the defendant's body, two additional baggies containing a white crystalline substance and a package of Kool-Aid. Hubbard County Sheriff's Deputy Jim Card took custody of the three micro baggies and Kool-Aid package. The micro baggies tested positive for methamphetamine and weighed over 3 grams combined. The Kool-Aid package is pending analysis by the Minnesota BCA.

A check of the above named defendant's criminal history reveals the following felony convictions: 1st degree manslaughter; 11-KX-03-268; 5th degree controlled substance possession; 11-CR-07-753; 1st degree controlled substance sale; 11-CR-10-399; 5th degree controlled substance possession; 29-CR-11-626; 5th degree controlled substance possession; 29-CR-12-414; 5th degree controlled substance possession; 11-CR-13-2087.

Count: 1 Drugs - 5th Degree - Possess Schedule 1,2,3,4 - Not Small Amount Marijuana; Penalty: 5 years and/or \$10,000.00; Count: 2 Introduce Contraband-Drug/Liquor into Jail/Lockup/Prison; Penalty: 1 year in jail, a \$3,000 fine, or both

**Daunte Robert Curry**, (18), 6010 Flowing Creek Trl, Cass Lake, MN 56633

On May 15, 2019 at approximately 2:22 a.m. Deputy Anderson conducted a traffic stop on Hwy. 2 in the County of Hubbard after Deputy Anderson observed a suspended object hanging from the rearview mirror. Deputy Anderson observed that the vehicle was slower than normal to come to a stop. Deputy Anderson approached the vehicle and spoke with the driver, identified as Michael Staples. While speaking with Staples, Deputy Anderson detected an odor of marijuana coming from inside the vehicle. Staples admitted to smoking marijuana earlier that day and provided Deputy Anderson with a burnt marijuana roach from the ashtray. Deputy Anderson then asked Staples and the male passenger, later identified as Daunte Robert Curry, to exit the vehicle while it was searched for additional controlled substances. During the search, Deputy Anderson located a red bag on the backseat of the vehicle. Michael stated that the bag belonged to Curry. Located inside the bag were two handguns, one of which was a pellet gun and the other was a 9 mm Glock 43 firearm. Deputy Anderson then placed Curry under arrest and placed him in the squad car. Curry advised Deputy Anderson that he was on probation for a felony assault offense.

Deputy Anderson observed that the 9mm Glock had a loaded magazine. The handgun was seized and placed into evidence.

Deputy M. Stein spoke with Staples who stated that he picked up Curry in Bemidji and that Curry was in possession of the red bag when he picked Curry up and Curry brought it into the vehicle. Deputy M. Stein observed text messages sent from Curry to Staples which stated "I got u on gas b I gotta go to btown grab this thang n come back to protect my s\*\*t it got shot up my lil bro almost got hit."

Deputy Stein transported Curry to the Hubbard County Law Enforcement Center where he obtained a post Miranda statement from Curry. Curry confirmed Staples had picked him up in Bemidji and was going to drop Curry off at his house. Curry stated that the text messages were old. Curry did state that his house was recently shot up.

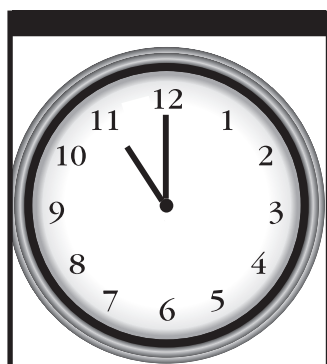
Curry was adjudicated delinquent in Cass County Court File 11-JV-17-2047 on 12/20/2017 for 2nd Degree Assault and is subject to EJJ. Curry is currently on supervised probation.
