# Pilot, passenger walk away from plane crash near GP

McCormick County Sheriff's deputies responded to a series of break-ins and a plane crash just before Christ-

Deputies were dispatched to the Georgia Pacific lumber vard at Main Street and SR 28 on Wednesday, Dec. 19. They talked with a witness who said he saw a plane flying just above three trees, and it crashed into woods near the road.

Deputies then talked with the pilot and passenger, who said that the plane experienced engine problems. They said they put it down in the safest possible area,

and both walked away from the crash unhurt.

Earlier in the month, a report of a stolen trailer attracted deputies who searched the surrounding area. They located the trailer in a wooded area off Barksdale Ferry Road, identified a suspect and obtained warrants.

Two days later, deputies saw the subject driving on SR 10, performed a traffic stop and informed the subject of felony warrants on file. They noticed a clear plastic bag on the passenger seat and advised the subject that he would be charged with possession of methamphet-

A further search of the vehicle resulted in an additional charge of possession of burglary tools (bolt cutters, electric drill, flashlight, screwdrivers, etc.). The subject was taken to the detention center to await a bond hearing, and the trailer was returned to its owner.

Deputies also responded to break-ins in the Morrah Bridge Road and Charlotte Road areas. Scenes were processed and the incidents remain under investigation.

The Westtown Apartments were also the scene of a break-in and theft of two video game consoles and several games. Fingerprints were lifted and submitted to the S.C. Law Enforcement Division (SLED) for identification. The case remains under investigation pending identification from SLED.

## Annie Laurie Gebauer celebrates 100th birthday



## Town of McCormick streetscape will have to be rescoped and rebid

The regular McCormick Town Council meeting was held on Tuesday, Dec. 11, at the McCormick One Stop Conference Room and was called to order at 7 p.m. by Mayor Roy Smith Jr.

Council members Dolly Franklin and Eric Butler were absent. Council members Ann Seymour, Nathan Jones, Alvin Jennings, Dolly Franklin and Town Attorney John D. Compton, III were in attendance.

Invocation and Pledge of Allegiance and Approval of Agenda as Presented.

Rett Harbison, JLA – Report on Streetscape Bid Process, Award of Contract, and Action by Council - bidding was over \$291,000 over the \$500,000 grant awarded. The project will be rescoped and rebid. The fencing, landscaping and resurfacing the streets and sidewalks are still on, but limiting it from Virginia Street to Augusta may help keep bidding in range of current grant. Future grants will fund Phases 2 (roundabout at Cotton Gin Complex) and Phase 3 (Memorial and pedestrian walkway in front of the Town Hall).

Rick Green, Community Services Director, Upper Savannah Council of Governments - Town Zoning Ordinance & Zoning Map. The proposed Town of McCormick Zoning Map has been digitized and will be available at Town Hall and the web as soon as it is approved.

Public or Employee Comments – None

Minutes from Nov. 8, 2018 Regular Meeting; November Accounts Payable; and October 2018 Financial Statement were all approved as presented.

Office Manager/Finance Director Cheryl Daniels -Deborah Peeler has accepted the office clerk position and will start work on Jan. 7. Overall, operations are running

Superintendent James Robinson – Safety training for the month of December will be Lock Out and Tag Out. Overall, things are running smoothly.

Charles Hegler spoke for Glenn Hill and Edward Deason for Waste Water and Water Treatment Plants. New pump for West Town lift station. Second and final toxicity tests were good (each test costs approximately \$1,000). Overall, operations are running smoothly even though there was high lake turbidity. Lake level on Dec. 7 was 326.6 feet. All settling basins have been washed out as of last week. Total flow 14,633,000 gallons, compared to last year's 16,071,000. Total sewer gallons treated was 13,170,000 gallons compared to last year's 13,330,000. Deason attended the annual DHEC surface water meeting in Columbia, where McCormick Water Plant was awarded the Area-Wide Optimization Program Excellence Award. The Water Plant would like to thank the commissioners for the meal in Greenwood and wishes everyone a very Merry Christmas.
