## South Carolina Army National Guard proposes to demolish the McCormick Armory

The South Carolina Army National Guard (SCARNG) is proud of its historic presence in South Carolina and recognizes the role the McCormick Readiness Center has played throughout history. In 2011, the Keeper of the National Register of Historic Places (NRHP) determined that the McCormick Armory was eligible for listing with the NRHP. The SCARNG respects the significance of this determination and is committed to protecting and preserving its cultural and historic resources to the best of its ability.

Over the years, the McCormick Armory has deteriorated to a hazardous extent. The building is plagued by asbestos, lead paint, mold, and a failing roof system. The structure poses a risk to both soldiers at the facility, as well as members of the McCormick community who may access the building. The SCARNG has considered numerous options to repair and renovate the building, but is unable to secure the funding necessary to safely maintain the structure. Consequently, the SCARNG has made the difficult decision to

pursue the demolition of the McCormick Armory.

The SCARNG will maintain its presence in the McCormick community and plans to continue to use the McCormick facility for parking and military storage. The SCARNG values the McCormick community's interest in this proposal. ## Deputies arrest mother, son, two others for home burglary

McCormick County Sheriff's deputies made arrests in one burglary last week and are continuing to investigate a second.

A woman called county dispatch last Friday, said her husband was holding her at gunpoint in the Lost Wilderness area and refusing to let her go. When deputies arrived, a man came out and was questioned. He admitted he had a rifle, stated that his estranged wife had left months ago, but returned to cut a chain link lock, broken out a window and gained en-

The General Sessions Court convened last week, and there were 14 felony cases presented by the McCormick Sheriff's Office to the grand jury. All 14 cases were truebilled, meaning indictments will be forthcoming. Additionally, 11 felony cases were tried and disposed of.

In late 2017, the sheriff's office partnered with Cornerstone and CVS to have a drug drop box installed in the front lobby of the justice center. This is an apparatus in which

### Sheriff's Department fundraiser

On Wednesday afternoon, Sheriff Clarke Stearns spoke to the Good Shepherd Women's and Men's Clubs. He described in detail many of the challenges he and his deputies face in protecting the citizens of McCormick County. Many of the situations included dealing with active shooters (being fired upon). One deputy was wounded and is on medical leave. They have protective vests, but no protective headgear. And they also

have no basic tactical tools such as a battering ram, pry bars, etc. His team consists of 18 deputies (seven of which are Tactical members) and himself. The McCormick County Council has approved (over the past two years) a budget of \$2,000 annually for uniforms and equipment. This has left the department with no at White Hardware, 210 S. Main means to provide for the safety of the Tactical Deputies and obtain the necessary equipment. He has asked for funds to purchase seven Kevlar helmets (as used by the military) at a cost of \$350 each. Our goal is to raise these funds and more to pro-

vide necessary equipment also.

McCormick County has over 3,000 households and with a donation of \$10 per household we can easily provide funds that would meet the department's needs now and for the next year or two.

try to his residence.

A female was brought out, questioned, and she admitted to having bolt cutters and breaking the window to gain entry. She said she was trying to reconcile her relationship with the home owner.

During questioning, the couple's son, girlfriend and a third person drove in, and the son said he had dropped his mother off so she could pick up some of her belongings. Further questioning determined that the son and girlfriend had also entered the residence while the third person remained on the porch.

The mother, son and girlfriend were arrested for second degree burglary and the additional person for accessory to burglary. All four were transported to the county detention center to await bond hearing. The case continues to be investigated and additional charges are pending.

"When we receive calls involving firearms, we take them very seriously as the stakes are automatically higher," said Sheriff Clarke Stearns. "Fortunately, in this case, no one was injured. Deputies did an excellent job in investigating this case and flawlessly handling what could have been a volatile scene. That's why we train hard and often."

Deputies responded to a burglary complaint in the Julia Mae Saxon Road area last Tuesday. The victim said that after she had returned home, she noticed that items including computer games and a small TV were missing. Deputies observed damage to the front door, photographed the scene and lifted several fingerprints.

They also canvassed the neighborhood, and a witness said he had seen two black males, one carrying a black book bag and a Spider Man book bag. One was wearing a black ball cap and hoodie, red jogging pants and purple and red shoes. Anyone seeing a person or persons matching this description is asked to
