"We are extremely proud of Deputy Rushton," said McCormick County Sheriff Clarke Stearns. "Ty is extremely dedicated and committed to the law enforcement profession, and I'm confident he will be an asset to the McCormick County Sheriff's Office. We welcome him into our law enforcement family."

"Deputy Rushton comes from a long line of law enforcement heritage," Stearns said. "His grandfather Buddy Rushton was once a McCormick County deputy and his father Bobby Rushton is a retired McCormick County deputy.

### Sheriff's need for protection equipment draws donations

McCormick residents recently demonstrated their support for the McCormick County Sheriff's Office by donating more than \$9,000 to the department to buy protective equipment for deputies.

McCormick Lions Club member Jerry Dargis led a three-day campaign at the Savannah Lakes Village Recreation Center that attracted 251 contributors donating \$8,813 to the cause. Combined with donations from 120 contributors at a Good Shepherd Catholic Church pancake breakfast and from members of the McCormick Car Club at a holiday dinner, the goal has been reached.

"Contributions were more than generous," said Dargis. "Sitting at a table and receiving donations was really moving.

"I thought I knew a lot of people in the Village, but I met so many more and hope we can meet again. Thanks to the volunteers who helped over the three days. This community is amazing. Thank you," Dargis said.

Deputies were busy last week with a dog bite, a stolen car and firearm and drug possession.

A toddler in the Lost Wilderness area was bitten by a dog and brought to the medical center. Deputies called the dog owner, directed him to quarantine the dog, isolate it from people and other dogs and informed the S.C. Department of Health and Environmental Control (DHEC) of the incident. The case remains under DHEC investigation.

A car was reported stolen from in front of Sam's convenience store in Clarks Hill, Sunday, Jan. 13. The owner said he was in the store for a few minutes, then realized his truck was missing. The truck contained two handguns and a cell phone.

Five days later, Friday, Jan. 18, the vehicle was involved in a police pursuit in Richmond County, Ga. The driver crashed the vehicle and ran into nearby woods. Richmond County deputies impounded the vehicle, processed it for fingerprints and are continuing to work the case with McCormick.

On Thursday, Jan. 17, deputies made a traffic stop for speeding, wrote a citation, then smelled an odor of marijuana. Deputies conducted a probable cause search, found both marijuana and a handgun, and arrested the driver for possession of a firearm by a convicted felon and possession of marijuana. They transported him to the detention center for booking and to await a bond hear-

### Police dept. makes arrest in car break-ins

The Town of McCormick had several reports over the last few weeks of unlocked vehicles being broken into and items being taken out. The investigation leads to a possible suspect who was identified as Jakenzie D. Moore, a black male 21 years of age. After enough evidence was collected, an arrest warrant was issued and the subject was taken into custody. Moore has been charged with one count of attempted motor break in and one count of breaking into a motor vehicle.

The McCormick Police Department encourages residents to keep their vehicles locked at all times. Do not leave valuables inside the car.

### Energy and rental/ mortgage assistance funds are now available

The Low-Income Home Energy Assistance Program (LIHEAP) and General Emergency Assistance Program (GEAP) are federally-funded programs designed to assist eligible low-income households meet home heating, cooling, and housing needs. Home energy is defined as residential heating and cooling, and to increase energy self-sufficiency; thereby reducing the vulnerability resulting from energy needs. The LIHEAP program is also designed to intervene in energy-related crisis situations and to conduct outreach. The GEAP program provides rental/mortgage assistance for individuals facing immediate eviction. The GLEAMNS Human Resources Commission, Inc. Community Service Block Grant (CSBG) LIHEAP and GEAP programs are making appointments for energy and rental assistance. Some of the goals of the LIHEAP and GEAP programs for the 2019 program year are to expand outreach to previously un-served households, reduce and/or prevent poverty, increase efficiency of energy usage, and target energy and rental assistance to eligible households with the highest needs and lowest incomes.
