Village of Bement discusses possibly purchasing new reporting database program for police department

No action was taken on Tuesday December 11, but the Bement Village Board did discuss the possibility of purchasing a new reporting database program software for the Police Department.

Bement Police Officer David Lansford stated, "Basically the way I do reports right now is I put forms in Microsoft Word." This he states causes issues when looking up someone as he has to dig through records. He went on to add that by 2020, the FBI will mandate all Police departments to record reports in a similar fashion to the programs

Lansford brought up three different proposals from Dynamic Public Safety, Crime-Star, and Caliber. He stated that Dynamic Public Safety was not user friendly, and he did not see that as an option. He stated the other two: Crime Star and Caliber both were good options, with Caliber being the best option is his opinion. Lansford stated, "Basically sharing information with other law enforcements and I am a very big fan of that because that's about the only way really you can crack down on a lot of stuff by using experience and information from other agencies."

The village board decided to table the item for now, once more information from Caliber is obtained.

Audit in Good Shape and Other News

Neil Kuester of Feller & Kuester CPAs LLP from Champaign conducted Bement's Village audit stating, "Overall it's in good shape. We did some tidying up of the bank accounts. Some accounting issues, but extremely minor."

The liquor committee discussed the possibility of adding another Class A license last month and unanimously decided there was no need. The village board agreed Tuesday evening.

The village board approved end of the year bonuses for full time employees \$150 and \$75 for part time employees.

Tindle sentenced to 15 years in prison for vehicular hijacking with baby inside

Seth Tindle, 22, of Atwood pleaded guilty before Douglas County Judge Rick Broch on Wednesday, January 2, to a single count of vehicular hijacking, a Class 1 felony. Tindle was sentenced to 15 years in prison for stealing a car in Atwood with a baby inside.
