### New Restaurant Grading Hook, Line and Sinker System Aims To Better Inform, **Protect Consumers**

Illinois public media news With the new year comes new changes to the way Illinois restaurants are graded after food safety inspections. Instead of receiving a numerical score, all food establishments will being assigned a color: red, yellow, or green.

Red signals a restaurant has been closed for food safety violations. Yellow signals a food safety alert and green signals satisfactory compliance.

Previously, restaurants were given a score based on how many violations to the food safety code inspectors found, said Jim Roberts, director of environmental health at the Champaign-Urbana Public Health District.

But sometimes high scores could hide serious violations, he said.

In addition, food establishments would often focus on the number instead of seeking to understand how they got their score and what changes they need to make to protect consumers.

And scoring systems varied across the state, "so there was lack of uniformity for the consumer," Roberts said.

"People found over time that scores lacked predictive value of predicting whether this place may result in a food-borne illness or not," Roberts said. A low score didn't necessarily correlate with a greater public health risk, or vice versa.

The new grading system adopts a model code from the FDA that has been recommended since the mid-90s and is now finally getting adopted in full across the state.

Roberts said the colors better inform consumers about the risk of food-borne illness from dining there. And inspectors will focus on making both short-term and longterm corrections to problems that are identified during the inspection process.

In Champaign-Urbana, food establishments are already required to post the colored placards in their front window, since the public health district already passed an ordinance requiring it. But each jurisdiction across the state sets its own rules regarding the posting of the information.

1000 point scorers

Last week, junior Aliyah Holloman scored the one thousandth point of her career for the VGH girls' basketball team, joining Jared Stevens, who surpassed the milestone for the boys' team earlier this season.

A quick look at the list of 1000 point scorers that Colin Likas keeps for the News-Gazette shows that they were the 25th and 26th athletes to do so while wearing VG, ABL, Homer, Heritage or VGH uniforms. According to the list, the school record holder for points scored for the Heritage girls is Candi McGee, who scored 2344 points in her career, which ended in 2004. Her sister Carmen finished with 1731 in 2004. For Villa Grove, Lizzy Smith tops the charts, finishing with 1262 points in 2013. Jodi Watson comes in second, finishing with 1214 points in 2003. I have to say that the Likas list isn't comprehensive, and my old eyes certainly may have missed folks also.

On the boys' side, Villa Grove's John Greger tops the charts, finishing his career in 1957 with 1797 points. Homer's Bill Lewis tallied 1656 by the time his career ended in 1952 to finish second on our list.


college exploits. Exciting times on the high school hard wood
