


Albert enjoyed tinkering in his garage, gardening and working in his yard.

Township proposal despite their own 2018. attorney's recommendation to hold-off, according to a press release from EDP Renewables. The proposed zoning is aimed at stopping wind farms from being built in the township. The Harvest Ridge Wind Farm has contracts with Newman Township landowners to build approximately 40 wind turbines in the township.

Neighboring Murdock Township enacted similar anti-wind zoning in October 2018, and shortly thereafter was sued by the Harvest Ridge Wind Farm.

Newman Township's attorney, Bob Lenz, recommended that the township wait to see the results of the Murdock Township lawsuit prior to taking any action.

"Don't be in a hurry to adopt it, otherwise you are volunteering to be in a lawsuit that you don't need to be

meeting held on January 3, 2019, the majority of the Newman Township Trustees voted to move forward, despite their attorney's advice. Trustees Samantha Hutchinson, Mark Fraser and Jason Bosch voted in favor of the anti-wind and Roger Sy voted against

The zoning saga continued on January 10, at the next regularly scheduled township meeting, when the trustees were presented with yet another recommendation from a second attorney urging them to hold off on enacting their proposed zoning.

This time, the request came from attorney Andrew Bequette, representing a significant local business in Newman Township. Mr.

Newman Township Trustees are waiting for a final version of the zoning proposal in order to enact it. The next vote has not yet been scheduled.
