### City Council prepares for II iois Motor Fuel Tax increase

As a part of the State of Illinois budget for the current year, the Motor Fuel Tax (MTF) rate has doubled. The current understanding of the City Council is that Tuscola will receive a 68 percent increase of about \$78,000 due to the Motor Fuel Tax increase. The Council also stated that Tuscola is projected to receive \$295,000 of additional Motor Fuel Tax funds over the next three years, as a part of the Rebuild Illinois capital plan. Although this is a onetime disbursement, the Council

The purpose of these meetings are to review the annual reports and to provide an opportunity for them to comment or even make a written report to the City Council that concerns the conduct and administration of the TIF districts. ers Mike Carroll and Mark Petty will begin building at the site, with water and sewer installation happening as soon as this week.

The Property Tax Levy is still available for public inspection and comment. Currently, the board has not received any comments and the ordinance that enacts the levy will be available at the December 9 meeting.

As mentioned at the public hearing last month, we are still in the middle of the sixty-day objection period for the establishment of the Special Service Area to address the drainage issues at Ironhorse. If there are an insufficient number of objections received, then a Special Meeting will be scheduled for December 30 to present an ordinance to establish the SSA. However, if a sufficient number of objections are filed, there will be no need for a meeting or ordinance since the process will end at that point.

The Council also:

- Approved the minutes from the previous meeting on November 12.

- Approved the payment of bills in the amount of \$164,315.17.

- Approved the purchase of a new sewer pump at the South Sewer plant in the amount of \$11,929.

- Approved to lease the Community Building with alcohol on January 24 for the National Wild Turkey Federation Banquet. - Approved to lease the Community Building with alcohol December 13-15 for a Wedding reception.

#### Tuscola Sch **DOI Board sets Tru**t tion nearing

The Tuscola School Board met for their monthly meeting at 7 p.m. on November 25.

The 2019 Tax Levy and Resolution will be voted on at the December 19 board meeting. Due to the fact that there are a lot of unknowns associated with the levy, the board is opting to hold a Truth in Taxation hearing. The hearing necessary since the estimated increase in the levy is over five percent, which requires a mandatory hearing.

The board is also still in the process of going through stacks to fill the vacant seat.

In his Superintendent's Report, Gary Alexander announced that the budget is in line with what was expected, the heat in the High School weight room was replaced, the air in the East Prairie computer lab was fixed, and that the Board Retreat will be held before the December meeting to discuss policy and procedures.

He also reported that the Schools received a commendable rating on this year's state report card. State and federal laws require public school districts to release report cards each year. The Illinois Report Card is an annual report released by the Illinois State Board of Education that shows how the state, and each school and district, are progressing on a wide range of educational goals. The full report card is available to view on the School District's website.

In his Principal's Report, High School Principal Steve Fiscus reported to the Board

that the Blood Drive on November 12 was very successful. They received eleven pints over their goal, and had twenty new donors. He also announced that this year's Christmas Band and Choir concert will be held on December 8. The event begins at 2 p.m. and will feature both East Prairie and the High School. Finally, he told the Board that the High School will change how they do their finals schedule this year. In years past,
