Curtis was preceded in death by his parents, one son, Leland Atteberry, and two brothers-in-law.

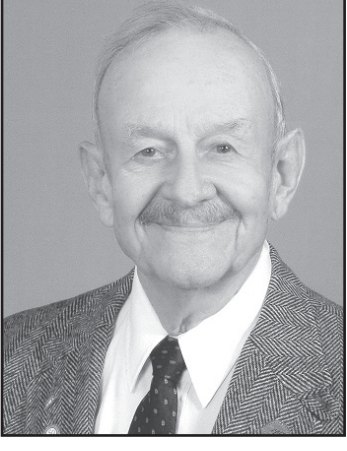
