The Village of Sidney Board of Trustees met on Wednesday, January 23 in the Sidney Community Building meeting room at 6:30 p.m. Village of Sidney President Chuck White brought the meeting to order at 6:41 p.m.

First on the agenda was the task of appointing a replacement to serve out the rest of Village of Sidney President White's unexpired term through April 2021.

A motion from Trustee Leroy Schluter seconded by Trustee Tyler Bickers to appoint Trustee John Finn to serve out the rest of Village of Sidney President Chuck White's unexpired term through April 2021 carried

following discussion amongst the trustees and President

Resigning Village of Sidney President Chuck White thanked Trustee Finn for his willingness to serve out the remainder of his unexpired term as Village of Sidney President. Village of Sidney President Chuck White is resigning effective January 31 and Village of Sidney Board of Trustees Trustee John Finn will be sworn in as Village of Sidney President at the Monday, February 4 Village of Sidney Board of Trustees

It was additionally noted that paid time off for some federal holidays; i.e. Martin Luther King Jr., etc. had been taken away at some point and were no longer being offered to village employees. A motion from Trustee Cyndi Mc-Cloud seconded by Trustee Jason Arrasmith to provide paid time off for all federal holidays for Village of Sidney employees to include the day after Thanksgiving carried.

The Village of Sidney Board of Trustees moved on to discuss village job descriptions and pay beginning with the Village of Sidney Člerk position as the need to hire and train an individual is essential pursuant to the announcement of Village of Sidney Clerk Carol Moore's retiretion and sick time along with ment effective April 1, 2019.

The following was decided for the position following extensive discussion. An individual filling the position will work 45 hours a month minimum for \$1,200.00 a month. Hours of work at the Village of Sidney Clerk's office are from 8:00 a.m. – 12:00 p.m. Monday, Wednesday, and Thursday Required qualifications and skills for the job include having a high school education or GED, being computer literate and able to learn software, having basic math skills, having communication skills (being able to deescalate), and possessing organizational skills.
