## Dallas, San Antonio extend curfews

Dallas Mayor Eric Johnson declared a local state of disaster in the city, according to a news release, in response to the threats of rioting following the death of George Floyd, a black man who was killed last Monday in Minneapolis police custody.

The declaration, which is set to expire in seven days, allows the city manager to issue emergency regulations like curfews.

On Sunday, Dallas Police Chief Reneé Hall said a curfew will go into effect in the city at 7 p.m. and end at 6 a.m. "for the next several days," according to The Dallas Morning News. The curfew was set up as a result of increasing tensions between demonstrators and police officers at protests.

San Antonio Mayor Ron Nirenberg also announced a curfew for parts of his city. Nirenberg said Sunday that Alamo Plaza will be closed beginning at 6 p.m., while the rest of the downtown business district will be closed to the public at 10 p.m.

People violating the curfew and visiting those parts of the city could be subject to fines of up to \$1,000 and up to 180 days in jail. Sunday's announcement follows a curfew that Nirenberg issued for late Saturday night.

"We cannot allow anyone to loot or vandalize or threaten the lives and livelihoods of people in Dallas," Johnson said. "Enough is enough. We need to put a stop to the criminal destruction of our city."

Protesters also gathered in downtown Austin Sunday afternoon, spurred by the deaths of Floyd, and Michael Ramos, who was shot to death by an Austin police officer in late April.

Chanting, "APD are murderers" and, "No justice, no peace," protesters marched toward the state Capitol and Austin City Hall.

Austin police then critically injured a 20-year-old black protester when an officer shot him with "less-lethal" ammunition during a weekend filled with Texas demonstrations and violence, according to police Chief Brian Manley. Video also shows officers shooting at the people trying to get medical attention for the protester, whose name was not released.

On Monday, Manley said police cameras showed the critically injured protester was standing near police headquarters at around 11 p.m. when another man lobbed a water bottle, and then hurled his backpack, at officers guarding the building.

"One of the officers fired less-lethal munition at that individual, apparently, but it struck this victim instead. And this victim then fell to the ground, and it appears that he hit his head when he fell to the ground as well," Manley said.

Manley said that during protests Saturday, another Hispanic teenager, either 15 or 16, was struck in the forehead with less-lethal ammunition from officers. He said that case is also being investigated adding he was also in the hospital.

# Gov. Abbott calls for unity, peaceful protests

**Texas Governor Greg** Abbott held a press conference in Dallas on Tuesday where he provided an update on Texas' response to protest violence across the state. In his remarks, the Governor called for swift justice in the case of George Floyd's death, and discussed the ways Texas is working with local law enforcement to maintain order and uphold public safety so that peaceful protestors can continue to make their voices heard.

"What happened to George Floyd was a horrific act of police brutality, and I join the millions

The camera, owned by Shawcor and commonly used in the oil and gas industry, went missing when a truck with a slidein camper containing a mobile darkroom was swept away in the floodwaters of the Pedernales River southeast of Fredericksburg. The camper was located about 10 miles downstream, but the camera was not inside. The company is actively searching for the camera with support from DSHS and local authorities.

This type of radioactive source is called a "sealed source" because the radioactive material is sealed inside a capsule, which is in turn sealed inside the camera with protective shielding and other safety features. The entire camera is stored in a locked half-inchthick steel overpack box with radiation markings. Levels of radiation outside the camera, itself, are not dangerous.

To end the violence,

vandalism, and looting experienced across the state, the Governor has deployed DPS officers and Texas National Guardsmen to several cities in Texas—including 1,000 DPS officers and hundreds of Guardsmen to the Dallas-Fort Worth region. They are working alongside federal partners from the Federal Mayor Betsy Price, Dallas Police Chief Renee Hall, Fort Worth Police Chief Ed Kraus, Major General Tracy Norris of the Texas National Guard, and Texas Department of Public Safety (DPS) Director Colonel Steve McCraw.
