Willard Damont Bell-Wilson was indicted on three counts that allegedly occurred on July 2, 2020. He was indicted for the Felony 1 offenses of possession of a controlled substance (methamphetamine) with intent to deliver and possession of a controlled substance (Cocaine) with intent to deliver. He was indicted for evading arrest with a motor vehicle, a Felony 2. On that date, the Vernon Police Department K9, "Jak' assisted in the capture of Bell-Wilson. A Vernon Police officer attempted to make a traffic stop on a white suburban in the 1400 block of Nabers. The officer's report stated he recognized the driver, as having multiple felony warrants for his arrest. The suburban fled on residential streets before losing control, hitting a utility pole guideline and rolling. Bell allegedly got out of the vehicle and fled on foot. An officer released the K9 in pursuit and the dog took Bell down.

were signed over to the City of Vernon on a motion from trustee Chris Lehman. Superintendent jeff Byrd said the city plans to hand the two properties over to the Business Development Corporation as an incentive to recruit a business, such as a new truck stop, to be built on the old Gibson's lot.

The trustees approved a resolution request sanctioning the Wilbarger County 4-H Organization as an extracurricular activity, and an agreement for Wilbarger County Extension Staff to be considered Vernon ISD adjunct faculty. Byrd said both had been approved in the past. He said the current staff would be Landgon Reagan and Jennifer Trufan. He said if the Extension adds new staff, the trustees will need to come back and approve them as well

The trustees, on a motion from Kevin Young, approved a request from Western Trail Wind to waive the minimum new job creation requirement from six full-time jobs down to 2 full-time jobs.

Also, on a motion by Young, the trustees approved the extension of a phone contract with Austen Consultants.

Trustees discussed the 2021 Wilbarger County Appraisal District's adopted operational budget. Byrd said the final number of what VISD's percentage of the CAD budget has not been set, as Chief Appraiser Sandy Burkett was still waiting on some entities to set a tax rate. Byrd guessed it would be about 40 percent of the CAD budget, whuich was set at \$561,367.51 for next year.

"They went up substantially," Byrd said, so even though VISD went down on its tax rate, it would probably still mean VISD paying more to the CAD. He said if the district's percentage was 40 percent, then VISD's portion would by around \$224,000 - an increase of \$15,000 to \$20,000 from the current year.

Vernon's Koch takes 3rd at Gooding Pro Rodeo

The Professional Rodeo Cowboys Association will conclude its 2020 regular season on Sept. 30. At that point, the top 15 will advance to the Dec. 3-12 Wrangler National Finals Rodeo at Globe Life Field

in Arlington. With that in mind, world class competitors aggressively worked rodeos throughout the United States last weekend. Pro rodeos were held in the Texas towns of Mineral Wells, Abilene and Buffalo. Competitors also rode in St. George, Utah; Gooding, Idaho; Nephi, Utah; Redmond, Oregon, and in other cities.

The Palo Pinto County **Livestock Association** Rodeo in Mineral Wells began Wednesday, Sept. 16 (with a slack performance), and concluded Saturday, Sept. 19. The rodeo drew numerous world class athletes such as Shad Mayfield of Clovis, New Mexico, who is ranked No. 1 in the Professional Rodeo Cowbovs Association's 2020 tie-down roping world title race.

Mayfield, and Charlie Gibson, each turned in a time of 8.2 seconds. It was the second fastest tie-down roping time of the rodeo.

Mayfield also tied for seventh at the West Texas

Trevor Brazile, a 25-time world champion, came in third in the steer roping third round with a 10.1. Brazile, who is semiretired, regularly competes in steer roping competitions and is a world title race contender in that event. Brazile is a former Vernon College star who

lives in Decatur. In bareback riding at the Abilene rodeo, three-time world champion Will Lowe, who lives in the Amarillo area, finished second in bareback riding with a score of 83. Lowe is a former Vernon College star.

Hunter Koch of Vernon

Fair & Rodeo in and his team roping partner Kolton Schmidt finished third in team roping at the Gooding Pro Rodeo in Idaho with a 4.7. Koch is ranked No. 13 in the PRCA's 2020 team roping heeling world standings (Sept. 21).

BULL RIDER KILLED

Rowdy Lee Swanson, an Oklahoma cowbov, was killed in a bull riding accident on Thursday, Sept. 17, at the Palo Pinto County Livestock Association's PRCA Rodeo in Mineral Wells. He was 20.

According to the PRCA, which sanctioned the annual Mineral Wells rodeo, Swanson passed away on Thursday following injuries sustained that night while competing. Swanson was bucked off of a bull named Gritty, which is owned by the Rafter G Rodeo Co. of Terrell.

"We are deeply saddened by the passing of Rowdy Swanson at the

ProRodeo in Mineral Wells, Texas," PRCA chief executive officer George Taylor told prorodeo.com. "The hearts of the entire rodeo community go out to Rowdy's family in this tragic time. We will continue to keep Rowdy and his family in our thoughts and prayers."

Swanson, who is from Duncan, Oklahoma, is classified as a permit holder, which means that he was attempting to earn a PRCA membership card. He also was a student at Oklahoma State University in Stillwater, Oklahoma, where he was studying animal science.

The Palo Pinto County Livestock Association posted a statement about Swanson's death on the rodeo's Facebook page on Friday.

'We are deeply saddened by the passing of Rowdy Swanson following injuries sustained at the Palo Pinto County Livestock Association's PRCA Pro Rodeo," PPCLA Rodeo Chairman Scott Fenner said in a statement. "The entire rodeo committee and our rodeo family extend our heartfelt condolences and deepest sympathies to Rowdy's mother Venessa, his brother Roper, and his entire family."
