All of the spending rests by the three officials were approved unanimously on a motion from Commissioner Josh Patterson.

The commission also approved the paying of bills, on a motion by Phillip Graf, by a 3 to 1 vote. Commissioner Wright opposed the motion, on the basis that he wasn't sure that all of the three outgoing elected officials' departments expenses had received prior approval. Wright said, "I haven't got to read them."

The commissioners unanimously approved a resolution with the Texas Indigent Defense Commission for

"No amount has been set yet," Judge Greg Tyra told the commission, saying it helps pay some of the county's attorney fees for court defendants. "It's usually \$10,000 to 14,000 per year."

The transfer of the county's interest in tax foreclosed properties at 2802 and 2804 Bacon was transferred to the City of Vernon, on a motion from Wright. Judge Tyra said the lots were behind the old Gibson property along the Frontage Road. He said the City intended to give the lots to the Vernon Business Development Corporation, to market the whole area for development, perhaps as a new

Covid cases continue across area

The Tuesday evening Covid-19 case count showed Wilbarger County with 243 cases, 48 in Hardeman County and 19 in Foard County. There were just 7 reported as active in Wilbarger, while 16 were active in Hardeman and none in Foard.

The NTSH-Vernon campus reported 4 patients and 8 staff were positive as of Monday. Last week, The state reported there just three active patient cases, and one active staff case. The numbers peaked two weeks ago at the hospital with 52 active cases -- 12 were staff and 40 were patients.

For most people, the coronavirus causes mild or moderate symptoms, such as fever and a cough that clear up in two to three weeks. For some, especially older adults and people with existing health problems, it can cause more severe illness, including pneumonia, and
