AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF LAKE CLARKE SHORES, FLORIDA, AMENDING CHAPTER 125 ZONING OF THE CODE OF ORDINANCES OF THE TOWN OF LAKE CLARKE SHORES, ARTICLE I. IN GENERAL, SECTION 125-1. DEFINITIONS TO AMEND THE DEFINITION OF RESTAURANT; AMENDING SECTION 125-4. DECISIONS BY ZONING BOARD OF ADJUSTMENT, FUNCTION OF TOWN COUNCIL TO SPECIFY THAT THE ZONING BOARD OF ADJUSTMENT IS AN ADVISORY BOARD TO THE TOWN COUNCIL; AMENDING ARTICLE VI. DISTRICTS, DIVISION 3.
