Notice of Public Hearing

In accordance with the "National Environmental Policy Act (NEPA) Implementing Instructions for Airport Actions"- FAA Order 5050.4B and "Environmental Impacts: Policies and Procedures"- FAA Order 1050.1F, the Russell County Airport Board and Russell County Fiscal Court intend to conduct a public hearing for a 3,400' extension of their existing parallel taxiway to the north end of the runway. The project includes: a 3,400' x 35' taxiway extension with LED taxiway lighting and signage.

The purpose of the hearing is to address the potential economic, social and environmental affects of the project and its consistency with the goals and objectives of each affected area's land use or planning strategy.

Issues to be addressed include wetlands and streams, archaeological and historical sites, biological issues, airport noise and lighting and social affects. In accordance with 5050.4B, a draft copy of the Environmental Assessment document will be made available for public viewing 30 days prior to the date of this public hearing at the following locations: the Russell County Judge Executive Office at 410 Monument Square Jamestown, Kentucky; the Russell County Airport Terminal at 628 C. Smith Road, Russell Springs, Kentucky; and Unlimited Marine at 2624 S Hwy 127 Russell Springs, Kentucky 42642.

The public hearing will be held on Monday April 6, 2020 from 6:00p.m. to 8:00p.m. local time in the Russell County Airport Terminal. Written comments should be submitted by Thursday April 16, 2020.
