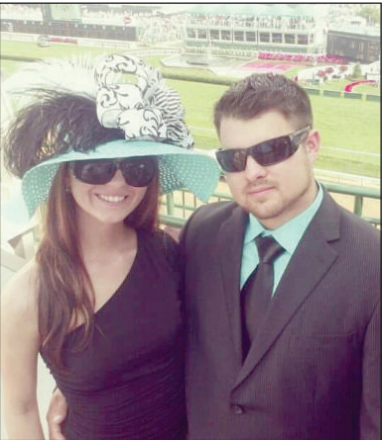

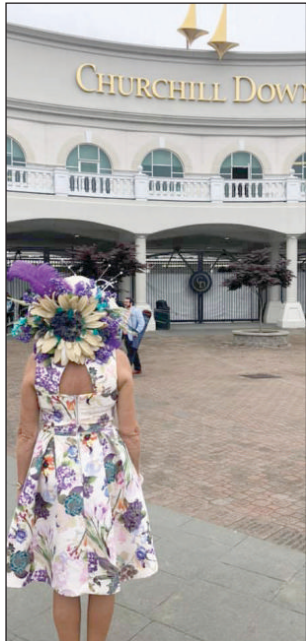

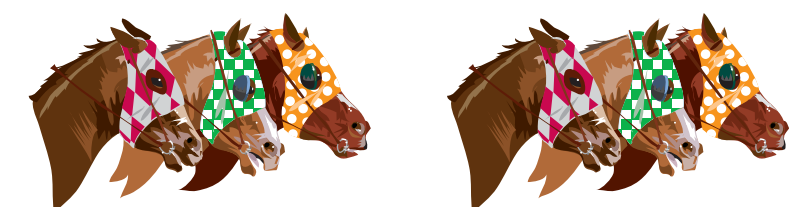

berland Family Medical website, telehealth can be used for follow up visits, management of chronic conditions, medication management, mild cold or flu symptoms, urinary tract infections, rashes, and other acute care needs.

Many doctors and nurse practitioners at local offices had positive words to say about this new way of offering treatment.

Jenny Eldridge with Cumberland Family Medical Center Inc. said that all of their centers are offering Dr. On Call, a 24 hour a day, 7 day a week telehealth service. Cumberland Family Medical Centers are located across Lake Cumberland areas, and they are all offering this service. Regarding their telehealth services, contact a local Cumberland Family Medical Center with any questions.

Both of Russell County Hospital Doctor Clinics, Family Practice Associates and Primary Care Associates, also spoke about telehealth.

"Telehealth is very new to me, but I love that we are able to offer continuity of care and this allows us to see patients virtually," said Dr. Leann Cooper who practices at Family Practice Associates. "We can refill medications and take care of them the best we can. Also, patients need this type of assurance. I have really liked it so far and that we are able to still see people face to face."

ARNP Terani Robertson of Primary Care Associates had incredibly positive things to say about telehealth.

"Telehealth works well, and overall, the patients have been very receptive," Terani said. "A lot of people are scared to come in, but this helps people with those worries. Also, the flexibility that is offered with this service is also greatly beneficial."

Other doctor offices may be offering telehealth as well. Reach out to your medical provider to see if they are offering these services to better assist you.
